1 AN ACT concerning

2 **Higher Education – Douglas J. J. Peters Veterans of the Afghanistan and Iraq**
3 **Conflicts Scholarship – Repeal of Service Terminal Date**

4 FOR the purpose of repealing the service terminal date required to be eligible for the
5 Douglas J. J. Peters Veterans of the Afghanistan and Iraq Conflicts Scholarship; and
6 generally relating to the Douglas J. J. Peters Veterans of the Afghanistan and Iraq
7 Conflicts Scholarship.

8 BY repealing and reenacting, with amendments,
9 Article – Education
10 Section 18–604(a)
11 Annotated Code of Maryland
12 (2022 Replacement Volume and 2023 Supplement)

13 BY repealing and reenacting, without amendments,
14 Article – Education
15 Section 18–604(b) and (c)
16 Annotated Code of Maryland

2 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
3 That the Laws of Maryland read as follows:

4 **Article – Education**

5 18–604.

6 (a) For purposes of this section, an individual served in the Afghanistan or Iraq
7 conflict if the individual was a member of the uniformed services of the United States who
8 served in:

9 (1) Afghanistan or contiguous air space, as defined in federal regulations,
10 on or after October 24, 2001[, and before a terminal date to be prescribed by the United
11 States Secretary of Defense]; or

12 (2) Iraq or contiguous waters or air space, as defined in federal regulations,
13 on or after March 19, 2003[, and before a terminal date to be prescribed by the United
14 States Secretary of Defense].

15 (b) There is a Douglas J. J. Peters Veterans of the Afghanistan and Iraq Conflicts
16 Scholarship.

17 (c) An individual may apply to the Office for a scholarship under this section if
18 the individual:

19 (1) Is a resident of Maryland;

20 (2) (i) Is accepted for admission or enrolled in the regular
21 undergraduate program at an eligible institution; or

22 (ii) Is accepted for admission or enrolled in a 2–year terminal
23 certificate program in which the course work is acceptable for transfer credit for an
24 accredited baccalaureate program in an eligible institution; and

25 (3) (i) 1. Is a veteran, as defined under § 9–901 of the State
26 Government Article, who served in the Afghanistan or Iraq conflict;

27 2. Is an active duty member of the armed forces who served
28 in the Afghanistan or Iraq conflict; or

29 3. Is a member of a reserve component of the armed forces of
30 the United States or the Maryland National Guard who was activated as a result of the
31 Afghanistan or Iraq conflict described in subsection (a) of this section; or

32 (ii) Is a son, daughter, stepson, stepdaughter, or spouse of:

1 1. A veteran or active duty member of the armed forces who
2 is serving or has served in the Afghanistan or Iraq conflict; or

3 2. A member of the reserve or Maryland National Guard who
4 was activated as a result of the Afghanistan or Iraq conflict described in subsection (a) of
5 this section.

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency
7 measure, is necessary for the immediate preservation of the public health or safety, has
8 been passed by a yea and nay vote supported by three-fifths of all the members elected to
9 each of the two Houses of the General Assembly, and shall take effect from the date it is
10 enacted.
