**State Procurement - Prompt Payment of Suppliers**

---

This bill requires contractors on State contracts to promptly pay “suppliers” any undisputed amount that is owed, and otherwise adds suppliers to the State’s statutory prompt payment requirements. A “supplier” is defined as a person that has supplied labor or materials to a contractor in the prosecution of work provided for in a State procurement contract.

---

**Fiscal Summary**

**State Effect:** None. State agencies can implement the bill’s requirements with existing budgeted resources. No effect on revenues.

**Local Effect:** None. The bill applies only to State procurement contracts.

**Small Business Effect:** Minimal.

---

**Analysis**

**Bill Summary/Current Law:** Under current law, it is the policy of the State that, for work under a State procurement contract, a contractor must promptly pay a subcontractor any undisputed amount to which the subcontractor is entitled. Likewise, subcontractors must promptly pay any undisputed amounts to lower tier subcontractors. Generally, undisputed amounts must be paid by contractors (or subcontractors to lower tier subcontractors) within 10 days of receiving a progress or final payment from the State. State law includes procedures for resolving disputes between subcontractors and contractors regarding a contractor’s or subcontractor’s failure to promptly pay undisputed amounts.

The bill adds “suppliers” to this payment and dispute resolution framework in the same manner as for contractor payments to subcontractors. The bill does not affect payments by subcontractors to suppliers.
