## FISCAL AND POLICY NOTE Third Reader

Senate Bill 895

(Senator Carter)(By Request - Baltimore City Administration)

Finance Economic Matters

### **Baltimore City - Alcoholic Beverages - Licensing Fees**

This bill authorizes the Baltimore City Board of License Commissioners to (1) increase annual, supplementary, and other alcoholic beverages licensing fees for specified licenses in Baltimore City; (2) set *per diem* and annual licensing fees for specified licenses; and (3) increase, from \$50 to \$78, renewal application fees for all alcoholic beverages licenses. **The bill takes effect July 1, 2024.** 

# **Fiscal Summary**

State Effect: None.

**Local Effect:** Baltimore City licensing and fee revenues may increase by \$823,200 beginning in FY 2025, and annually thereafter. Baltimore City expenditures are not affected.

**Small Business Effect:** Potential meaningful impact on small business restaurants, bars, and other alcoholic beverages license holders due to increased fees under the bill.

### **Analysis**

**Bill Summary/Current Law:** The bill increases specified alcoholic beverages licensing fees in Baltimore City, as detailed in **Exhibit 1**.

The bill requires the board to set *per diem* license fees for specified licenses, which are currently established in statute, and to set annual license fees for a Class BWLT beer, wine, and liquor (on premises) tasting license, as specified. Currently, the annual fees for a

Class BWLT beer, wine, and liquor (on premises) tasting license are \$200 for a 26-day tasting license; \$300 for a 52-day tasting license, and \$750 for a tasting license that may be used daily throughout the year.

Supplementary license fees, and other license fees, are increased from \$75 to \$120 for specified licenses under the bill.

**Local Revenues:** Baltimore City estimates the increase in existing alcoholic beverages licensing and related fees under the bill will increase city revenues by approximately \$823,200 beginning in fiscal 2025.

**Small Business Effect:** The bill may have a potential meaningful impact on small business restaurants, bars, and other alcoholic beverages license holders due to increased fees specified under the bill.
