### Allegany County - Property Tax Credit - Evergreen Heritage Center

This bill authorizes Allegany County and municipalities in the county to grant a property tax credit for property that is owned by Evergreen Heritage Center Foundation or Evergreen Heritage Center Holdings. The bill takes effect June 1, 2024, and applies to taxable years beginning after June 30, 2024.

#### **Fiscal Summary**

State Effect: None.

**Local Effect:** Allegany County property tax revenues may decrease by approximately \$5,300 annually beginning in FY 2025 to the extent the property tax credit is granted. County expenditures are not affected.

**Small Business Effect:** Potential meaningful. Evergreen Heritage Center Holdings could realize a reduction in county property taxes.

## **Analysis**

**Current Law: Exhibit 1** lists the current mandatory and optional property tax credits that are authorized in Allegany County. Allegany County is projected to collect approximately \$46.9 million in property tax revenues in fiscal 2024, as shown in the <u>County Revenue Outlook Report – Fiscal 2024</u>. **Local Fiscal Effect:** Evergreen Heritage Center Holdings owns one property located in Mt. Savage, Maryland. The property has a fiscal 2025 assessment of \$546,300. As a result of the property tax credit under the bill, Allegany County property tax revenues may decrease by approximately \$5,300 annually beginning in fiscal 2025. This estimate is based on a county property tax rate of \$0.9750 per \$100 of assessment.

The Evergreen Heritage Center, located on 130 acres in Western Maryland, is a historic farm that pre-dates the Revolutionary War. The property has been on the Maryland Historical Trust inventory of properties since 1976 and was added to the National Register in 2015. The heritage center features a six-bedroom farmhouse and barn originally built more than 200 years ago, plus over 100 acres of managed forest, multiple gardens and orchards, and landscaped grounds.
