Somerset County - Fire Companies - Appropriations

This bill increases the amount of funds that the Somerset County Commissioners must appropriate annually to the volunteer fire companies in Somerset County for fiscal 2025 through 2030. The required appropriation for fiscal 2030 will remain in effect for subsequent years unless altered by future legislation. **The bill takes effect July 1, 2024.**

Fiscal Summary

State Effect: None.

Local Effect: Somerset County expenditures for volunteer fire companies increase by \$7,300 in FY 2025 and by \$46,200 in FY 2030. County revenues are not affected.

Small Business Effect: None.

Analysis

Bill Summary: **Exhibit 1** details the increase in the Somerset County appropriation for each volunteer fire company for fiscal 2025 through 2030.

Current Law: The Public Local Laws of Somerset County require the county commissioners to appropriate funds to organized volunteer fire companies in the county. Appropriations made by the county commissioners to volunteer fire companies were last changed by Chapters 327 and 328 of 2018, which increased funding for fiscal 2019 through 2024. The legislation also required that the fiscal 2024 funding levels remain the same for each year thereafter, unless changed by subsequent legislation.

Local Fiscal Effect: There are eight organized volunteer fire companies in Somerset County. The county commissioners have provided funding to volunteer fire companies for over 45 years. As shown in Exhibit 1, total county appropriations to volunteer fire companies will increase by \$7,317 in fiscal 2025 and by \$46,154 in fiscal 2030 and subsequent years. This represents a 2.0% annual increase in county funding for each volunteer fire company.
