AMENDMENT NO. 1

On page 1, at the top of the page, insert "EMERGENCY BILL"; in the sponsor line, strike "Delegate Kerr" and substitute "Delegates Kerr, Bagnall, Bhandari, Cullison, Guzzone, Hill, S. Johnson, Kaiser, Lopez, Martinez, Pena-Melnyk, Rosenberg, Taveras, White Holland, Woods, and Woorman"; and in line 4, after "costs;" insert "requiring the Department of Budget and Management to study and report on certain grant or contract recipients;".

AMENDMENT NO. 2

On page 2, in line 27, after "TO" insert "THE GREATER OF"; and in line 28, after "GUIDANCE" insert "OR 15%".

AMENDMENT NO. 3

On page 2, after line 29, insert:

"SECTION 2. AND BE IT FURTHER ENACTED, That:

- (a) (1) This subsection applies only to a nonprofit organization that:
- (i) is the recipient or subrecipient of a grant or contract described under § 2–208(c) of the State Finance and Procurement Article, as enacted by Section 1 of this Act, that exceeds \$1,000,000; and
- (ii) receives an indirect cost rate set in accordance with § 2–208(c)(2) of the State Finance and Procurement Article, as enacted by Section 1 of this Act, between October 1, 2025, and October 1, 2028.
- (2) For each nonprofit organization described under paragraph (1) of this subsection, the Department of Budget and Management shall examine:
 - (i) the salaries of senior staff;

- (ii) the organization's administrative expenses; and
- (iii) if the organization was the recipient or subrecipient of a grant or contract and received an indirect cost rate set in accordance with § 2–208(c)(2) of the State Finance and Procurement Article before October 1, 2025, a comparison of the indirect cost rate received before October 1, 2025, and the rate received during the study period.
- (b) On or before December 1, 2028, the Department of Budget and Management shall report its findings under subsection (a) of this section to the Governor and, in accordance with § 2-1257 of the State Government Article, the Senate Budget and Taxation Committee and the House Health and Government Operations Committee.";

in line 30, strike "2." and substitute "3."; and strike beginning with "shall" in line 30 down through "2025" in line 31 and substitute "is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three–fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted".
