AMENDMENTS TO HOUSE BILL 930
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 9, after “circumstances;” insert “prohibiting an entity that receives a grant under the Program from using the grant funds to perform or induce an abortion on a pregnant woman except under certain circumstances;”.

AMENDMENT NO. 2

On page 5, after line 21, insert:

“(3) AN ENTITY THAT RECEIVES A GRANT UNDER THE PROGRAM MAY NOT USE THE GRANT FUNDS TO PERFORM OR INDUCE AN ABORTION ON A PREGNANT WOMAN:

(I) 1. WITHIN 24 HOURS AFTER THE WOMAN RECEIVES TRANSABDOMINAL ULTRASOUND IMAGING; OR

2. IF THE WOMAN RESIDES AT LEAST 100 MILES FROM THE FACILITY IN WHICH THE ABORTION WILL BE PERFORMED, WITHIN 2 HOURS AFTER THE WOMAN RECEIVES TRANSABDOMINAL ULTRASOUND IMAGING; AND

(II) UNLESS THE MEDICAL PROFESSIONAL PERFORMING THE TRANSABDOMINAL ULTRASOUND IMAGING REQUIRED UNDER ITEM (I) OF THIS PARAGRAPH:

1. IS TRAINED IN SONOGRAPHY AND WORKING UNDER THE SUPERVISION OF A QUALIFIED PROVIDER;

2. IF POSSIBLE, DETERMINES THE GESTATIONAL AGE OF THE FETUS BASED ON:

A. MEASUREMENT OF THE FETUS IN A MANNER CONSISTENT WITH THE STANDARD OF CARE; OR

B. IF ONLY THE GESTATIONAL SAC IS VISIBLE DURING THE TRANSABDOMINAL ULTRASOUND IMAGING, MEASUREMENT OF THE GESTATIONAL SAC;

3. IF GESTATIONAL AGE CANNOT BE DETERMINED UNDER ITEM 2 OF THIS ITEM, VERBALLY OFFERS TO THE WOMAN OTHER ULTRASOUND IMAGING TO DETERMINE GESTATIONAL AGE OF THE FETUS;

4. IF PRESENT AND VIEWABLE, INCLUDES IN THE ULTRASOUND IMAGE:

A. THE DIMENSIONS OF THE FETUS; AND

B. AN ACCURATE PORTRAYAL OF THE PRESENCE OF EXTERNAL MEMBERS AND INTERNAL ORGANS OF THE FETUS;

5. MAKES A PRINT OF THE ULTRASOUND IMAGE TO DOCUMENT ANY MEASUREMENTS TAKEN TO DETERMINE THE GESTATIONAL AGE OF THE FETUS;

6. VERBALLY OFFERS TO THE WOMAN DURING THE TRANSABDOMINAL ULTRASOUND IMAGING THE OPTION TO:

- A. VIEW THE ULTRASOUND IMAGE;
- B. RECEIVE A PRINTED COPY OF THE ULTRASOUND IMAGE; AND
- C. HEAR THE FETAL HEARTBEAT IN A MANNER CONSISTENT WITH THE STANDARD OF CARE; AND
- 7. OBTAINS FROM THE WOMAN WRITTEN CERTIFICATION THAT:

 - A. THE MEDICAL PROFESSIONAL PERFORMING THE TRANSABDOMINAL ULTRASOUND IMAGING OFFERED OPTIONS AS REQUIRED UNDER ITEM 6 OF THIS ITEM; AND
 - B. IF APPLICABLE, THE WOMAN RESIDES AT LEAST 100 MILES FROM THE FACILITY IN WHICH THE ABORTION WILL BE PERFORMED.”.
