## <u>AMENDMENTS TO SENATE BILL 750</u> (First Reading File Bill)

#### AMENDMENT NO. 1

On page 1, in line 2, strike "**Faculty**" and substitute "<u>**Part-Time Faculty**</u>"; in lines 3, 5, and 6, in each instance, strike "faculty" and substitute "<u>part-time faculty</u>"; in line 4, after "establishing" insert "<u>a</u>"; in the same line, strike "units" and substitute "<u>unit</u>"; and strike beginning with "authorizing" in line 5 down through "unit" in line 6 and substitute "<u>prohibiting certain bargaining units from electing to engage in consolidated collective bargaining</u>".

#### AMENDMENT NO.2

On page 2, in line 7, after "OR" insert "PART-TIME".

On page 3, strike in their entirety lines 3 through 11, inclusive; in line 12, strike the brackets; and in the same line, strike "(H)".

On page 4, after line 11, insert:

"(H) (1) "PART-TIME FACULTY" MEANS NONTENURE TRACK TEMPORARY, CONTINGENT, OR CONTRACTUAL ADJUNCT EMPLOYEES OF A SYSTEM INSTITUTION, MORGAN STATE UNIVERSITY, OR ST. MARY'S COLLEGE OF MARYLAND WHOSE PRIMARY ASSIGNMENTS INVOLVE ACADEMIC CLASSROOM INSTRUCTIONAL RESPONSIBILITIES AND WHO TEACH MORE THAN ONE CLASS PER SEMESTER.

# (II) ADJUNCT FACULTY WHO TEACH A STANDARDIZED, PRE-DESIGNED, AND TEMPORARY CURRICULUM PER COURSE AND WHOSE STATUS IS TEMPORARY, CONTINGENT, OR CONTRACTUAL ON A PER COURSE BASIS FOR A DEFINED PERIOD OF 12 WEEKS OR LESS; OR

## (III) STUDENT WORKERS.".

On page 5, in lines 7, 8, 10, 12, 15, 23, 24, and 28, in each instance, strike the brackets; in lines 10, 12, and 15, strike "(IV)", "(V)", and "(VI)", respectively; in line 11, after "FOR" insert "<u>PART-TIME</u>"; in lines 14 and 16, in each instance, strike ", EXCEPT FOR FACULTY"; and strike beginning with "EXCEPT" in line 28 down through "EACH" in line 29.

On page 6, in line 5, after "officers;" insert "<u>AND</u>"; strike beginning with "FACULTY" in line 6 down through "FACULTY" in line 9 and substitute "<u>ALL ELIGIBLE</u> <u>PART-TIME FACULTY</u>"; in line 10, strike "UNITS" and substitute "<u>UNIT</u>"; in line 11, strike "AND 5"; strike beginning with "CHOOSE" in line 11 down through "UNIT" in line 12 and substitute "<u>NOT ELECT TO ENGAGE IN CONSOLIDATED COLLECTIVE</u> <u>BARGAINING UNDER § 3-602 OF THIS TITLE</u>";

and in line 14, strike "2025" and substitute "2026".
