AMENDMENTS TO HOUSE BILL 1391
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with the first comma in line 2 down through “**Force**” in line 3 and substitute “**and Professional Development**”; strike beginning with the third “the” line 4 down through “Education” in line 6 and substitute “relevant stakeholders”; in line 6, strike “or” and substitute “and periodically”; in the same line, strike “and strategies”; in line 7, strike “for county boards of education”; strike beginning with “requiring” in line 7 down through “assessment;” in line 16; in line 16, strike “State”; in the same line, strike “of Education”; and strike beginning with “establishing” in line 17 down through “Education;” in line 18 and substitute “requiring the Career and Technical Education Committee and the CTE Skills Standards Advisory Committee to use the Department’s guidance and, if necessary, consult with the Department before incorporating the use of artificial intelligence into certain CTE-based actions;”.

AMENDMENT NO. 2

On page 2, after line 6, insert:

“(C) “CTE ADVISORY COMMITTEE” MEANS THE CTE SKILLS STANDARDS ADVISORY COMMITTEE ESTABLISHED UNDER § 21-210 OF THIS ARTICLE.”;

in line 7, strike “(C)” and substitute “(D)”; strike beginning with the first “THE” in line 11 down through “EDUCATION” in line 12 and substitute “RELEVANT STAKEHOLDERS”; in line 12, strike “OR UPDATE”; and strike beginning with the comma in line 20 down through the comma in line 21.

On pages 2 through 4, strike in their entirety the lines beginning with line 23 on page 2 through line 2 on page 4, inclusive, and substitute:

“(B) (1) THE DEPARTMENT SHALL PERIODICALLY UPDATE THE GUIDANCE TO REFLECT CHANGES IN ARTIFICIAL INTELLIGENCE, THE ETHICS THAT SURROUND ARTIFICIAL INTELLIGENCE, AND THE NEEDS OF STUDENTS, PARENTS, EDUCATORS, AND ADMINISTRATORS.

(2) THE DEPARTMENT SHALL CONTINUE TO CONSULT WITH REGULAR STAKEHOLDERS IN UPDATING THE GUIDANCE.

(C) (1) THE CTE COMMITTEE SHALL USE THE DEPARTMENT’S GUIDANCE AND, IF NECESSARY, CONSULT WITH THE DEPARTMENT BEFORE INCORPORATING THE USE OF ARTIFICIAL INTELLIGENCE INTO THE STATEWIDE FRAMEWORK FOR CTE.

(2) THE CTE ADVISORY COMMITTEE SHALL USE THE DEPARTMENT’S GUIDANCE AND, IF NECESSARY, CONSULT WITH THE DEPARTMENT BEFORE INCORPORATING THE USE OF ARTIFICIAL INTELLIGENCE INTO THE POST-CCR CTE PATHWAY THE CTE ADVISORY COMMITTEE RECOMMENDS TO THE CTE COMMITTEE.”.

On page 4, strike beginning “PROFESSIONAL” in line 6, down through “(C)” in line 13.

On pages 4 through 6, strike in their entirety the lines beginning with line 16 on page 4 through line 10 on page 6, inclusive.

On page 6, in line 11, strike “3.” and substitute “2.”; and strike beginning with “Section” in line 12 down through the period in line 14.
