AMENDMENTS TO SENATE BILL 341
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 7, after “government;” insert “requiring that raffle tickets are sold using age-verification measures to ensure that the buyer is at least a certain age;”; in line 8, after “received” insert “in-person or”; in the same line, strike “the” and substitute “a certain”; and in line 9, strike “boundaries of” and substitute “area in”.

AMENDMENT NO. 2

On page 5, in line 22, after “NOT” insert “ALLOW AN INDIVIDUAL OR GROUP OF INDIVIDUALS TO”; after line 28, insert:

“(I) SHALL BE SOLD USING ONLY AGE-VERIFICATION MEASURES TO ENSURE THAT THE BUYER IS AT LEAST 18 YEARS OLD;”;

in line 29, after “RECEIVED” insert “IN-PERSON OR”; and in line 30, strike “OF BALTIMORE CITY” and substitute “DESCRIBED IN PARAGRAPH (2) OF THIS SUBSECTION”.

On page 5 in line 29, and on page 6 in line 1, strike “(I)” and “(II)”, respectively, and substitute “(II)” and “(III)”, respectively.

On page 6, in lines 6 and 7, strike “WITHIN THE GEOGRAPHICAL BOUNDARIES OF” and substitute “WITHIN AN AREA IN”; in line 7, after “CITY” insert “THAT IS BOUNDED AS FOLLOWS: FROM THE INTERSECTION OF WEST CAMDEN STREET AND SOUTH HOWARD STREET, SOUTH ON SOUTH HOWARD STREET TO WEST CONWAY STREET, WEST ON WEST CONWAY STREET TO SOUTH EUTAW STREET, SOUTH ON SOUTH EUTAW STREET TO WEST LEE STREET, WEST ON WEST LEE”.

STREET TO RUSSELL STREET, NORTH ON RUSSELL STREET TO SOUTH PACA STREET, NORTHEAST ON SOUTH PACA STREET TO WEST CAMDEN STREET, AND EAST ON WEST CAMDEN STREET TO THE INTERSECTION OF WEST CAMDEN STREET AND SOUTH HOWARD STREET"; and in line 14, after "2025." insert "It shall remain effective for a period of 3 years and, at the end of May 31, 2028, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.".
