#### AMENDMENT NO. 1

On page 1, in line 2, strike "**Cybersecurity** –"; in the same line, after "**Ecosystem**" insert "**Stakeholder Cybersecurity Workgroup**"; strike beginning with "requiring" in line 3 down through "ecosystem" in line 17 and substitute "establishing the Healthcare Ecosystem Stakeholder Cybersecurity Workgroup to develop strategies to prevent cybersecurity disruptions to the healthcare ecosystem, ensure the continuous delivery of essential healthcare ecosystem services, and enhance recovery efforts of the healthcare ecosystem following a cybersecurity incident; and generally relating to the Healthcare Ecosystem Stakeholder Cybersecurity Workgroup".

On pages 1 and 2, strike in their entirety the lines beginning with line 18 on page 1 through line 31 on page 2, inclusive.

#### AMENDMENT NO. 2

On pages 2 through 13, strike in their entirety the lines beginning with line 32 on page 1 through line 5 on page 13, inclusive, and substitute:

## "<u>SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF</u> <u>MARYLAND, That:</u>".

On page 13, after line 29, insert:

"(9) "Workgroup" means the Healthcare Ecosystem Stakeholder Cybersecurity Workgroup.".

(1) one member of the Senate of Maryland, appointed by the President of the Senate;

(2) one member of the House of Delegates, appointed by the Speaker of the House;

(3) <u>the Chairman of the Maryland Health Care Commission, or the</u> <u>Chairman's designee:</u>

(4) the Maryland Insurance Commissioner, or the Commissioner's designee;

(5) the Secretary of Emergency Management, or the Secretary's designee;

(6) the State Chief Information Security Officer, or the State Chief Officer's designee;

(7) two representatives from the Subcommittee on Critical Infrastructure of the Maryland Cybersecurity Council, appointed by the Chair of the Maryland Cybersecurity Council;

(8) one representative from each of the following organizations, designated by the head of the organization:

- (i) <u>one representative of the Cooperative Exchange</u>;
- (ii) one representative of the Electronic Health Record

Association;

(iii) one representative of the Maryland League of Life and Health

<u>Insurers;</u>

- (iv) one representative of the Maryland Hospital Association; and
- (v) one representative of the Maryland Cybersecurity Association;

(9) one representative of a pharmacy benefits manager, appointed by the Maryland Insurance Commissioner;

(10) the following representatives appointed by the Chairman of the Maryland Health Care Commission:

(i) <u>one representative of an electronic data interchange</u> <u>clearinghouse;</u>

- (ii) <u>one representative of a freestanding medical facility;</u>
- (iii) <u>one representative of a large hospital;</u>
- (iv) one representative of a small hospital;

(11) three representatives of a patient advocacy group, jointly appointed by the Chairman of the Maryland Health Care Commission and the Maryland Insurance <u>Commissioner.</u>

(d) <u>The Chairman of the Maryland Health Care Commission, or the</u> <u>Chairman's designee, and the Maryland Insurance Commissioner, or the</u> <u>Commissioner's designee, shall cochair the Workgroup.</u>

(e) <u>The Maryland Health Care Commission and the Maryland Insurance</u> <u>Administration shall provide staff for the Workgroup.</u>

(f) <u>A member of the Workgroup:</u>

(1) may not receive compensation as a member of the Workgroup; but

(2) is entitled to reimbursement for expenses under the Standard State Travel Regulations, as provided in the State budget.

(6) examine cybersecurity challenges affecting the healthcare ecosystem based on the threat and risk assessment";
