AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**Delegate Bagnall**” and substitute “**Delegates Bagnall, Pena-Melnyk, Cullison, Alston, Bhandari, Chisholm, Guzzone, Hill, Hutchinson, S. Johnson, Kaiser, Kerr, Kipke, Lopez, Martinez, M. Morgan, Reilly, Rosenberg, Szeliga, Taveras, Woods, Woorman, and Ross**”; and strike beginning with the second “and” in line 4 down through “workforce” in line 5.

AMENDMENT NO. 2

On page 2, strike beginning with “**EXEMPT**” in line 26 down through “**CODE**” in line 28.

On page 3, strike beginning with “**ENSURE:**” in line 10 down through “**(1)**” in line 11 and substitute “**ADVISE AND CONSULT ON**”; in line 11, strike “**RATES ARE SUFFICIENT TO PROVIDE**” and substitute “**RATE SUFFICIENCY, ENSURING**”; strike beginning with “**; AND**” in line 12 down through “**STATE**” in line 14; in line 17, strike the first comma and substitute “**OF**”; in line 19, after “**(2)**” insert “**THE DIRECTOR OF THE MARYLAND MEDICAL ASSISTANCE PROGRAM, OR THE DIRECTOR’S DESIGNEE;**”

(3) THE SECRETARY OF LABOR, OR THE SECRETARY’S DESIGNEE;

in the same line, after “**THE**” insert “**DEPUTY**”; in the same line, after “**SECRETARY**” insert “**OF HEALTH CARE FINANCING, OR THE DEPUTY SECRETARY’S DESIGNEE**”; and in line 23, after “**ORGANIZATIONS;**” insert “**AND**”.

On pages 3 and 4, strike beginning with “**ONE**” in line 24 on page 3 down through “**GROUP**” in line 4 on page 4 and substitute “**THREE REPRESENTATIVES OF PROVIDER ASSOCIATIONS, OF WHOM:**

1. TWO SHALL BE REPRESENTATIVES OF A RESIDENTIAL SERVICE AGENCY; AND

2. ONE SHALL BE A REPRESENTATIVE OF AN EMPLOYER TRADE ASSOCIATION”.

On page 4, in line 10, after “**THE**” insert “**DEPUTY**”; in the same line, after “**SECRETARY**” insert “**OF HEALTH CARE FINANCING, OR THE DEPUTY SECRETARY’S DESIGNEE,**”; in line 15, strike the first comma and substitute “**OF**”; in line 18, strike the second comma and substitute “**AND**”; in the same line, strike the third comma; in line 19, strike “**AND FINANCIAL**”; and strike beginning with “**(1)**” in line 21 down through “**(5)**” in line 30.

On page 5, in line 7, strike “**ON A QUARTERLY BASIS**” and substitute “**ANNUALLY**”.

On page 6, strike beginning with “**DISTRIBUTING**” in line 7 down through “**EXPERIENCE**” in line 31 and substitute “**CURRENT AND PROPOSED PAYMENT RATES**”; and strike beginning with “**WITH**” in line 32 down through “**REPORT**” in line 33.

On page 7, in line 15, after “**SERVICES;**” insert “AND”; and strike beginning with the semicolon in line 17 down through “**SERVICES**” in line 24.

On pages 7 and 8, strike in their entirety the lines beginning with line 25 on page 7 through line 21 on page 8, inclusive.

On page 8, in line 25, after “**CATEGORIES;**” insert “AND”; and strike beginning with “**EXAMINE**” in line 26 down through “**(3)**” in line 30.

On pages 8 and 9, strike beginning with “**; AND**” in line 31 on page 8 down through “**CONSUMERS**” in line 2 on page 9.

On page 9, strike beginning with “**THE**” in line 7 down through “**(3)**” in line 25; and in line 26, strike “**AN AFFIRMATIVE VOTE OF AT LEAST SEVEN MEMBERS**” and substitute “A MAJORITY VOTE”.

On pages 9 and 10, strike beginning with “**(4)**” in line 27 on page 9 down through “**(II)**” in line 5 on page 10 and substitute “(C)”.

On page 10, in line 5, strike “**POST**” and substitute “THE DEPARTMENT SHALL POST”; in lines 7 and 11, strike “**(C)**” and “**(D)**”, respectively, and substitute “(D)” and “(E)”, respectively; in line 17, after “the” insert “Deputy”; and in the same line, after “Secretary” insert “of Health Care Financing, or the Deputy Secretary’s designee,”.
