## AMENDMENT NO. 1

On page 1, in line 7, after "renewal;" insert "<u>prohibiting the Board from using</u> <u>certain information as a factor in determining whether to issue or renew a license;</u>"; in line 8, after "year;" insert "<u>altering the penalties that the Board may impose for certain violations;</u>"; and in line 17, after "(b)" insert "<u>and 11–2802</u>".

### AMENDMENT NO. 2

On page 2, in line 11, strike the second "and"; in line 12, after "(ii)" insert "<u>SELECTED FROM A LIST OF INDIVIDUALS RECOMMENDED BY THE MEMBERS OF</u> <u>THE ANNE ARUNDEL COUNTY HOUSE OR SENATE DELEGATION TO THE</u> <u>GENERAL ASSEMBLY; AND</u>

## <u>(III)</u>";

in line 14, strike "two" and substitute "<u>THREE</u>"; in line 19, strike "**5** YEARS" and substitute "<u>1 YEAR</u>"; in line 26, before "THE" insert "<u>(A)</u>"; and in the same line, strike the colon.

On page 3, in line 1, strike "(1)"; strike beginning with the semicolon in line 3 down through "APPLICATION" in line 5; after line 5, insert:

"(B) <u>THE BOARD MAY NOT USE ANY RACE OR ETHNICITY INFORMATION</u> <u>INCLUDED ON AN APPLICATION FOR THE ISSUANCE OF A LICENSE OR LICENSE</u> <u>RENEWAL AS A FACTOR IN DETERMINING WHETHER TO ISSUE OR RENEW THE</u> <u>LICENSE.</u>";

and after line 10, insert:

## "<u>11–2802.</u>

(a) [The Board may impose a fine not exceeding \$2,500 or suspend a license or both for] FOR a violation that is cause for license suspension under the alcoholic beverage laws affecting the county, THE BOARD MAY:

# (1) FOR A FIRST OFFENSE, IMPOSE A FINE NOT EXCEEDING \$1,000;

# (2) FOR A SECOND OFFENSE IN THE SAME 24–MONTH PERIOD, IMPOSE A FINE NOT EXCEEDING \$2,000 OR SUSPEND THE LICENSE OR BOTH; AND

# (3) FOR EACH SUBSEQUENT OFFENSE IN THE SAME 24–MONTH PERIOD, IMPOSE A FINE NOT EXCEEDING \$2,500 OR SUSPEND THE LICENSE OR BOTH.

(b) A fine or suspension under subsection (a) of this section is in addition to any term or condition that the Board may impose as a result of the violation.".
