#### AMENDMENT NO. 1

On page 1, in the sponsor line, strike "Delegate Kerr" and substitute "Delegates Kerr, Alston, Bagnall, Bhandari, Chisholm, Cullison, Guzzone, Hill, Hutchinson, S. Johnson, Kaiser, Kipke, Lopez, Martinez, M. Morgan, Pena-Melnyk, Reilly, Rosenberg, Ross, Szeliga, Taveras, White Holland, Woods, and Woorman"; in line 2, strike "Cybersecurity –"; in the same line, after "Ecosystem" insert "Stakeholder Cybersecurity Workgroup"; strike beginning with "requiring" in line 3 down through "ecosystem" in line 17 and substitute "establishing the Healthcare Ecosystem Stakeholder Cybersecurity Workgroup to develop strategies to prevent cybersecurity disruptions to the healthcare ecosystem, ensure the continuous delivery of essential healthcare ecosystem services, and enhance recovery efforts of the healthcare ecosystem following a cybersecurity incident; and generally relating to the Healthcare Ecosystem Stakeholder Cybersecurity Workgroup"; and strike beginning with "cybersecurity" in line 17 down through "ecosystem" in line 18 and substitute "the Healthcare Ecosystem Stakeholder Cybersecurity Workgroup".

On pages 1 through 3, strike in their entirety the lines beginning with line 19 on page 1 through line 2 on page 3, inclusive.

#### AMENDMENT NO. 2

On pages 3 through 13, strike in their entirety the lines beginning with line 3 on page 3 through line 17 on page 13, inclusive, and substitute:

"SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That:".

On page 14, after line 13, insert:

- "(2) The purpose of the Workgroup is to develop strategies to:
- (i) prevent cybersecurity disruptions to healthcare ecosystem operations;
- (ii) ensure the continuous delivery of essential healthcare ecosystem services; and
- (iii) enhance recovery efforts of the healthcare ecosystem following a cybersecurity incident.";

strike in their entirety lines 17 through 28, inclusive, and substitute:

- "(c) The Workgroup consists of the following members:
- (1) one member of the Senate of Maryland, appointed by the President of the Senate;
- (2) one member of the House of Delegates, appointed by the Speaker of the House;
- (3) the Chairman of the Maryland Health Care Commission, or the Chairman's designee;

- the Maryland Insurance Commissioner, or the Commissioner's (4) designee; the Secretary of Emergency Management, or the Secretary's (5)designee: the State Chief Information Security Officer, or the State Chief (6) Officer's designee; two representatives from the Subcommittee on Critical (7)Infrastructure of the Maryland Cybersecurity Council, appointed by the Chair of the Maryland Cybersecurity Council; one representative from each of the following organizations, (8)designated by the head of the organization: one representative of the Cooperative Exchange; (i) one representative of the Electronic Health Record (ii) Association; (iii) one representative of the Maryland League of Life and Health Insurers; one representative of the Maryland Hospital Association; and (iv) one representative of the Maryland Cybersecurity (v)
- (9) one representative of a pharmacy benefits manager, appointed by the Maryland Insurance Commissioner;

- (10) the following representatives appointed by the Chairman of the Maryland Health Care Commission:
- (i) one representative of an electronic data interchange clearinghouse;
  - (ii) one representative of a freestanding medical facility;
  - (iii) one representative of a large hospital;
  - (iv) one representative of a small hospital;
  - (v) one representative of an inpatient psychiatric hospital; and
  - (vi) one representative of a health information exchange; and
- (11) three representatives of a patient advocacy group, jointly appointed by the Chairman of the Maryland Health Care Commission and the Maryland Insurance Commissioner.
- (d) The Chairman of the Maryland Health Care Commission, or the Chairman's designee, and the Maryland Insurance Commissioner, or the Commissioner's designee, shall cochair the Workgroup.
- (e) The Maryland Health Care Commission and the Maryland Insurance Administration shall provide staff for the Workgroup.
  - (f) A member of the Workgroup:
    - (1) may not receive compensation as a member of the Workgroup; but

in line 29, strike "(c)" and substitute "(g)"; in the same line, strike "workgroup" and substitute "Workgroup"; and in line 30, after "capabilities" insert "required for the delivery of health care during a cybersecurity attack".

On page 15, in line 3, after "State" insert "against the essential health care capabilities and identified functional requirements"; strike beginning with "identify" in line 6 down through "ecosystem" in line 7 and substitute "develop an ecosystem cybersecurity threat and risk assessment based on the essential health care capabilities and supporting functions;

(6) examine cybersecurity challenges affecting the healthcare ecosystem based on the threat and risk assessment";

in line 8, strike "(6)" and substitute "(7)"; in line 10, strike the second "and"; strike in their entirety lines 11 through 13, inclusive, and substitute:

- "(8) make recommendations for adopting and maintaining cybersecurity regulatory standards; and
- (9) make recommendations for ensuring that essential capabilities and supporting functions are resilient to disruption.";

in line 14, strike "(d)" and substitute "(h)"; in the same line, strike "July" and substitute "January"; in lines 14 and 15 and 19 and 20, in each instance, strike "Maryland Department of Emergency Management" and substitute "Workgroup"; in lines 15 and 16, strike "defining the scope and contents of the State's healthcare ecosystem" and substitute "of its findings and recommendations"; in lines 16 and 21, in each instance, after "Governor," insert "the Secretary of Emergency Management,"; in lines 16 and 21, in each instance, strike "Chair" and substitute "Chairman"; in line 19, strike "July" and
