On page 3, in line 4, after "(b)" insert "<u>(1)</u>"; in line 5, strike "(1)"; in the same line, strike "Publish once" and substitute "<u>PUBLISH A NOTICE:</u>

in line 7, strike the first comma and substitute "<u>; OR</u>

"(B) (1) ON OR BEFORE DECEMBER 1, 2025, AND EACH DECEMBER 1 THEREAFTER, THE REGISTER OF EACH COUNTY AND BALTIMORE CITY SHALL, FOR THE 12-MONTH PERIOD ENDING ON THE PREVIOUS OCTOBER 31, REPORT TO THE MARYLAND REGISTER OF WILLS ASSOCIATION ON THE NUMBER OF ESTATES FOR WHICH AN INTERESTED PARTY OBJECTED TO THE APPOINTMENT OF A PERSONAL REPRESENTATIVE, FILED A CLAIM AGAINST THE ESTATE, OR CHALLENGED A WILL BECAUSE THE INTERESTED PARTY:

(I) DID NOT RECEIVE A NOTICE FROM THE REGISTER THROUGH THE MAIL; OR

(II) LEARNED ABOUT THE OPENING OF THE ESTATE BY READING A NOTICE IN A NEWSPAPER.

(2) ON OR BEFORE DECEMBER 31, 2025, AND EACH DECEMBER 31 THEREAFTER, THE MARYLAND REGISTER OF WILLS ASSOCIATION SHALL REPORT TO THE GOVERNOR AND, IN ACCORDANCE WITH § 2–1257 OF THE STATE GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY ON THE INFORMATION REPORTED BY THE REGISTERS UNDER PARAGRAPH (1) OF THIS SUBSECTION, DISAGGREGATED BY TYPE AND JURISDICTION.".
