AMENDMENTS TO HOUSE BILL 1503  
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 3, after “Management” insert “and the governing body of a public institution of higher education”.

AMENDMENT NO. 2

On page 5, in lines 15 and 20, in each instance, after “**SECRETARY**” insert “**, OR THE GOVERNING BODY OF A PUBLIC INSTITUTION OF HIGHER EDUCATION,**”; in lines 20 and 21, strike “**OF THE DEPARTMENT**”; in line 26, strike “**THE DEPARTMENT SHALL FILE QUARTERLY**” and substitute “**QUARTERLY**”; and in line 27, after “**REPORTS**” insert “**SHALL BE FILED**”.

On page 6, strike beginning with “**TO**” in line 2 down through “**AUTHORITY**” in line 3; in line 3, after “**LEAVE**” insert “**IN ACCORDANCE WITH ESTABLISHED PROCEDURES**”; in lines 21 and 22, strike “**APPOINTING AUTHORITY MAY REQUIRE AN**”; in line 22, after “**SUBTITLE**” insert “**MAY BE REQUIRED**”; in line 23, strike “**THE APPOINTING AUTHORITY WITH**”; in line 27, strike “**TO THE APPOINTING AUTHORITY**”; and in lines 29 and 30, strike “**APPOINTING AUTHORITY’S**”.

On page 7, in line 6, strike “**BY THE DEPARTMENT**”; strike beginning with “**EMPLOYEE’S**” in line 7 down through “**THE**” in line 8; in line 9, after “**SUBSECTION**” insert “**SHALL BE WAIVED**”; strike beginning with the second “**THE**” in line 11 down through “**LEAVE**” in line 12 and substitute “**LEAVE MAY BE DENIED**”; in line 21, strike “**THE APPOINTING AUTHORITY WITH**”; strike beginning with “**ON**” in line 26 down through “**REDUCE**” in line 27; and in line 28, after “**ENTITLED**” insert “**MAY NOT BE REDUCED**”.

On page 8, strike beginning with “EMPLOYEE’S” in line 17 down through “**THE**” in line 18; in line 18, after “**ACT**” insert “MAY BE COUNTED”; strike beginning with “**THE**” in line 21 down through “**DESIGNATES**” in line 22; in line 22, after “**LEAVE**” insert “IS DESIGNATED”; strike beginning with “EMPLOYEE’S” in line 25 down through the first “**THE**” in line 26; and in line 26, after “**EMPLOYEE**” insert “IS NOTIFIED”.
