AMENDMENTS TO SENATE BILL 154  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “**Termination**”; in lines 3 and 5, in each instance, strike “making permanent” and substitute “extending”; in line 7, strike “terminating” and substitute “altering the staff and duties of”; and in line 17, strike “8-901” and substitute “8-908”.

On pages 1 and 2, strike in their entirety the lines beginning with line 20 on page 1 through line 10 on page 2, inclusive.

AMENDMENT NO. 2

On page 3, in line 1, in each instance, strike the bracket; in the same line, strike “**AFTER**”; and in the same line, strike “2027” and substitute “2028”.

On page 4, in line 23, in each instance, strike the bracket; in the same line, strike “**FISCAL YEAR**”; and in the same line, strike “2027” and substitute “2028”.

AMENDMENT NO. 3

On page 5, strike in their entirety lines 1 through 19, inclusive; in line 20, strike the bracket; and in lines 22 and 23, strike “Office of the Attorney General” and substitute “**SECRETARY OF THE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT**”.

On page 6, in line 6, strike “Attorney General” and substitute “**SECRETARY OF THE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT**”; in line 7, strike “Office of the Attorney General” and substitute “**DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT**”; in line 8, after “(e)” insert “**(1)**”; in the same line, strike “A” and substitute “**EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**”.

**SUBSECTION, A**"; in lines 9 and 10, strike "(1)" and "(2)", respectively, and substitute "**(I)**" and "**(II)**", respectively; after line 11, insert:

**"(2) A MEMBER OF THE TASK FORCE DESCRIBED UNDER SUBSECTION (B)(2) OF THIS SECTION MAY RECEIVE REASONABLE COMPENSATION, INCLUDING A STIPEND, AS DETERMINED BY THE SECRETARY OF HOUSING AND COMMUNITY DEVELOPMENT."**;

in line 18, strike "2022, and each January 1 thereafter" and substitute "**2026**"; and in line 22, strike the bracket.

On pages 6 and 7, strike in their entirety the lines beginning with line 23 on page 6 through line 5 on page 7, inclusive.

**AMENDMENT NO. 4**

On page 7, strike in their entirety lines 6 and 7; in line 8, strike "6." and substitute "**3.**"; strike beginning with the second comma in line 8 down through the first comma in line 9; and in line 9, strike "October" and substitute "**June**".
