On page 1, in line 2, strike "**Termination**"; in lines 3 and 5, in each instance, strike "making permanent" and substitute "<u>extending</u>"; in line 7, strike "terminating" and substitute "<u>altering the staff and duties of</u>"; and in line 17, strike "8–901" and substitute "<u>8–908</u>".

On pages 1 and 2, strike in their entirety the lines beginning with line 20 on page 1 through line 10 on page 2, inclusive.

AMENDMENT NO. 2

On page 3, in line 1, in each instance, strike the bracket; in the same line, strike "**AFTER**"; and in the same line, strike "2027" and substitute "**2028**".

On page 4, in line 23, in each instance, strike the bracket; in the same line, strike "FISCAL YEAR"; and in the same line, strike "2027" and substitute "<u>2028</u>".

AMENDMENT NO. 3

On page 5, strike in their entirety lines 1 through 19, inclusive; in line 20, strike the bracket; and in lines 22 and 23, strike "Office of the Attorney General" and substitute "SECRETARY OF THE DEPARTMENT OF HOUSING AND COMMUNITY <u>DEVELOPMENT</u>".

SUBSECTION, A"; in lines 9 and 10, strike "(1)" and "(2)", respectively, and substitute "(I)" and "(II)", respectively; after line 11, insert:

"(2) <u>A MEMBER OF THE TASK FORCE DESCRIBED UNDER</u> <u>SUBSECTION (B)(2) OF THIS SECTION MAY RECEIVE REASONABLE</u> <u>COMPENSATION, INCLUDING A STIPEND, AS DETERMINED BY THE SECRETARY OF</u> <u>HOUSING AND COMMUNITY DEVELOPMENT.</u>";

in line 18, strike "2022, and each January 1 thereafter" and substitute "**2026**"; and in line 22, strike the bracket.

On pages 6 and 7, strike in their entirety the lines beginning with line 23 on page 6 through line 5 on page 7, inclusive.

AMENDMENT NO. 4

On page 7, strike in their entirety lines 6 and 7; in line 8, strike "6." and substitute "<u>3.</u>"; strike beginning with the second comma in line 8 down through the first comma in line 9; and in line 9, strike "October" and substitute "<u>June</u>".
