  - (3) SPENDING PLANS AND PRIORITIES;
- (4) A DETAILED DESCRIPTION OF ANY INITIATIVE FUNDED WITH FUNDS UNDER TITLE 7, SUBTITLE 2, PART II OF THE PUBLIC UTILITIES ARTICLE, INCLUDING PERFORMANCE MEASURES IF APPLICABLE; AND
- (5) INFORMATION ON PUBLIC HEARINGS CONDUCTED WITHIN THE STATE, COUNTY, OR MUNICIPALITY REGARDING THE PROGRAMS, PROJECTS, OR INITIATIVES UNDER TITLE 7, SUBTITLE 2, PART II OF THE PUBLIC UTILITIES ARTICLE.

- (C) EACH PRIVATE ENTITY, NONPROFIT ORGANIZATION, OR GOVERNMENTAL ENTITY THAT RECEIVES FUNDING UNDER TITLE 7, SUBTITLE 2, PART II OF THE PUBLIC UTILITIES ARTICLE SHALL PROVIDE TO THE DEPARTMENT THE NECESSARY FINANCIAL INFORMATION RELATED TO PROGRAMS, PROJECTS, OR INITIATIVES UNDER TITLE 7, SUBTITLE 2, PART II OF THE PUBLIC UTILITIES ARTICLE TO INCLUDE AS INFORMATION ON THE DASHBOARD.
- (D) THE DEPARTMENT SHALL ESTABLISH AN ONLINE PORTAL WITH INSTRUCTIONS FOR AN ENTITY TO REPORT OR UPLOAD REQUIRED INFORMATION TO THE DEPARTMENT FOR USE IN THE DASHBOARD.
- (E) TO THE EXTENT PRACTICABLE, THE DASHBOARD SHALL USE EXISTING PLATFORMS THAT PROVIDE DATA ON FUNDING RECIPIENTS AND PROJECTS FUNDED UNDER TITLE 7, SUBTITLE 2, PART II OF THE PUBLIC UTILITIES ARTICLE.
- (F) THE DASHBOARD SHALL BE DEVELOPED AND MAINTAINED USING FUNDING AVAILABLE UNDER THE EMPOWER MARYLAND PROGRAM.".
