AMENDMENT NO. 1

On page 1, in line 2, strike "Agriculture – Roosters" and substitute "Crimes Relating to Animals"; in the same line, after "Restrictions" insert "on Keeping Roosters"; in line 3, strike "unless authorized by the Department of Agriculture" and substitute "beginning on a certain date"; in line 4, after "a" insert "rooster movement—constrained through the use of a certain enclosure or tether"; strike beginning with the second "certain" in line 4 down through "date" in line 5; strike beginning with "authorizing" in line 5 down through "Act;" in line 7; in line 10, strike "Agriculture" and substitute "Criminal Law"; in line 11, strike "3–105.2" and substitute "10–608.1"; in line 13, strike "(2016" and substitute "(2021"; and strike in their entirety lines 21 and 22 and substitute:

"Article - Criminal Law

<u>10-608.1.</u>".

AMENDMENT NO. 2

On page 2, after line 2, insert:

- "(2) "ENCLOSURE" MEANS A STRUCTURE USED FOR CONFINEMENT, INCLUDING A WIRE CAGE OR AN ITEM TRADITIONALLY USED FOR ANOTHER PURPOSE SUCH AS A WATER TANK OR PLASTIC BARREL, THAT:
- (I) IS USED TO PROVIDE LONG-TERM HOUSING FOR ONE ADULT ROOSTER; AND
 - (II) PREVENTS INTERACTION WITH OTHER ROOSTERS.";

in lines 3 and 7, strike "(2)" and "(3)", respectively, and substitute "(3)" and "(4)", respectively; in lines 4, 5, 14, 16, and 19, in each instance, strike "A" and substitute "A"; in lines 8 and 10, in each instance, strike "IS" and substitute "IS"; in line 9, strike "HAS" and substitute "HAS"; in line 12, strike "COMMERCIAL" and substitute "COMMERCIAL"; in line 13, strike "THIS ARTICLE" and substitute "THE AGRICULTURE ARTICLE"; in line 17, strike "AN" and substitute "AN"; in line 18, strike "OR"; in line 23, strike "MEMBERSHIP" and substitute "MEMBERSHIP"; and in line 25, strike "AUTHORIZATION" and substitute "AUTHORIZATION".

On page 3, in lines 1, 3, 4, 5, and 7, in each instance, strike "**THE**" and substitute "**THE**"; strike beginning with "**MORE**" in line 1 down through "**25**" in line 2; in line 8, after "**KEPT**" insert "**; OR**

(6) A PERSON IF, ON REQUEST OF AN ANIMAL CONTROL OFFICER, AN OFFICER OF A COUNTY HUMANE SOCIETY, OR A POLICE OFFICER, THE PERSON PROVIDES IN WRITING PROOF THAT THE PERSON KEPT MORE ADULT HENS THAN ROOSTERS WITHIN THE IMMEDIATELY PRECEDING 6-MONTH PERIOD";

strike beginning with "UNLESS" in line 9 down through "DEPARTMENT," in line 10; in line 11, strike "AND KEPT" and substitute "MAY NOT KEEP A ROOSTER"; strike beginning with "MAY" in line 12 down through "PROPERTY" in line 16; and strike beginning with "A" in line 24 down through "SUBTITLE" in line 27 and substitute:

- "(1) A VIOLATION OF THIS SECTION IS A CIVIL OFFENSE.
- (2) A PERSON WHO VIOLATES THIS SECTION IS SUBJECT TO:
 - (I) FOR A FIRST OFFENSE, A WARNING;

- (II) FOR A SECOND OFFENSE, A CIVIL PENALTY OF UP TO \$500 PER ROOSTER; AND
- (III) FOR A THIRD OR SUBSEQUENT OFFENSE, A CIVIL PENALTY OF UP TO \$1,000 PER ROOSTER.
 - (3) THIS SECTION MAY BE ENFORCED BY:
 - (I) ANY STATE OR LOCAL LAW ENFORCEMENT OFFICER; OR
- (II) A LOCAL ANIMAL CONTROL AUTHORITY FOR THE JURISDICTION WHERE THE VIOLATION OCCURS".

On pages 3 and 4, strike in their entirety the lines beginning with line 28 on page 3 through line 5 on page 4, inclusive.
