- (3) THE LANDWARD BOUNDARY OF A TIDAL WETLAND.

On page 5, in line 3, after "(VIII)" insert "<u>PARTNERING WITH OPERATORS TO</u> IMPROVE CONSERVATION PRACTICES ON LEASED LAND;

<u>(IX)</u>";

in lines 6, 8, 10, 12, 13, and 14, strike "(IX)", "(X)", "(XI)", "(XII)", "(XIII)", and "(XIV)", respectively, and substitute "(X)", "(XI)", "(XII)", "(XIII)", "(XIV)", and "(XV)", respectively; in line 13, strike the second "AND"; and in line 16, after "RESEARCH;" insert "OR

(XVI) INSTALLATION OF A FIXED NATURAL BUFFER, INCLUDING WITHIN A 100–FOOT TIDAL BUFFER.".

On page 6, strike in their entirety lines 15 through 20, inclusive, and substitute:

"(E) FOR FISCAL YEAR 2026 AND EACH FISCAL YEAR THEREAFTER, THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF AT LEAST \$900,000 TO THE FUND.".
