AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and Wu" and substitute "<u>Wu, Atterbeary,</u> Fair, Griffith, Hartman, Hornberger, R. Long, Miller, Mireku–North, <u>Palakovich Carr, Roberts, Vogel, Wells, Wilkins, Wims, and Young</u>"; and strike beginning with "requiring" in line 6 down through "child" in line 8 and substitute "<u>requiring the remote registration process to provide an opportunity for the service</u> <u>member or other parent or guardian of a dependent child with a disability to make a</u> <u>certain note during the registration process; requiring a county board of education to</u> <u>ensure that a dependent child with a disability continues to receive a certain education</u> <u>without undue delay through a certain method</u>".

AMENDMENT NO. 2

On page 2, in line 14, strike "United States armed forces" and substitute "<u>UNIFORMED SERVICES, AS DEFINED IN 37 U.S.C. § 101</u>"; in line 15, strike "the National Guard OR"; and in line 16, strike "OF THE ARMED FORCES OF THE UNITED STATES" and substitute "<u>, AS DEFINED IN 37 U.S.C. § 101,</u>".

On page 3, strike beginning with "ON" in line 6 down through "STATE" in line 12 and substitute "<u>(I)</u> <u>THE REMOTE REGISTRATION PROCESS SHALL PROVIDE AN</u> <u>OPPORTUNITY FOR THE SERVICE MEMBER OR OTHER PARENT OR GUARDIAN OF</u> <u>A DEPENDENT CHILD TO NOTE WHETHER THE CHILD HAS AN INDIVIDUALIZED</u> <u>EDUCATION PROGRAM OR A 504 PLAN IN THE SENDING STATE.</u>

(II) IF A DEPENDENT CHILD HAS AN INDIVIDUALIZED EDUCATION PROGRAM OR A 504 PLAN IN THE SENDING STATE, THE COUNTY BOARD SHALL ENSURE THAT THE CHILD RECEIVES AN APPROPRIATE EDUCATION

WITHOUT UNDUE DELAY IN THE COUNTY IN WHICH THE CHILD ADVANCE ENROLLS, INCLUDING, IF APPROPRIATE, EDUCATION UNDER AN INDIVIDUALIZED EDUCATION PROGRAM OR IN ACCORDANCE WITH A 504 PLAN.

(III) <u>A COUNTY BOARD SHALL COORDINATE WITH A CHILD'S</u> <u>PARENT OR GUARDIAN AND THE SCHOOL SYSTEM IN THE SENDING STATE IN</u> <u>ORDER TO CARRY OUT THIS PARAGRAPH</u>";

in line 26, strike "A" and substitute "NOTWITHSTANDING ANY OTHER PROVISION OF LAW, A"; strike beginning with "ADVANCE" in line 26 down through "ENROLLS" in line 27 and substitute "HAS USED ADVANCE ENROLLMENT TO ENROLL"; strike beginning with the second "SCHOOL" in line 27 down through "SCHOOL" in line 28 and substitute "THE SCHOOL UNTIL THE END OF THE CURRENT SCHOOL YEAR, EVEN IF THE CHILD NO LONGER MEETS THE RESIDENCY REQUIREMENTS OF THE SCHOOL"; in line 29, strike "NOTWITHSTANDING ANY OTHER PROVISION OF LAW, A" and substitute "<u>A</u>"; in line 30, after "MEMBER" insert "<u>WHO USES ADVANCE</u> ENROLLMENT"; in the same line, strike "ALL"; and in line 32, strike "WHEN USING ADVANCE ENROLLMENT" and substitute "<u>IN THE SAME MANNER AS OTHER</u> STUDENTS ENROLLED IN THE SCHOOL".
