On page 8, in line 13, after "THE" insert "INITIAL".

On pages 8 and 9, strike beginning with "A" in line 24 on page 8 down through "(X)" in line 4 on page 9.

On page 9, in line 6, after the "REASON" insert ":

On pages 10 and 11, strike in their entirety the lines beginning with line 15 on page 10 through line 28 on page 11, inclusive.

On page 11, in line 29, strike "(G)" and substitute "(E)"; in line 30, strike "THE STATE AND"; in the same line, after "ENACT" insert "OR ENFORCE"; and in line 31, strike "GOVERNING LANDLORDS AND TENANTS, INCLUDING LEGISLATION ESTABLISHING" and substitute "THAT:

- (1) INCREASES THE MINIMUM NUMBER OF DAYS OF NOTICE REQUIRED IN SUBSECTION (B)(1) OF THIS SECTION TO AS MANY AS 14 DAYS;
- (2) DECREASES THE MINIMUM NUMBER OF DAYS OF NOTICE REQUIRED IN SUBSECTION (B)(1) OF THIS SECTION TO AS FEW AS 4 DAYS; OR
  - (3) ESTABLISHES".
