## AMENDMENT NO. 1

On page 1, in the sponsor line, strike "**Delegate Wilson**" and substitute "**Delegates Wilson**, **Alston**, **Bagnall**, **Bhandari**, **Cullison**, **Guzzone**, **Hill**, **S. Johnson**, **Kaiser**, **Kerr**, **Lopez**, **Martinez**, **Pena–Melnyk**, **Rosenberg**, **Ross**, **Taveras**, **White Holland**, **Woods**, **and Woorman**"; strike beginning with "a" in line 3 down through "and" in line 4; in line 5, strike the first "the" and substitute "<u>certain</u>"; and in line 17, strike "17–6B–05" and substitute "<u>17–6B–06</u>".

#### AMENDMENT NO. 2

On page 4, in line 21, strike "TITLE 17, SUBTITLE 6B" and substitute "§ 17–6B–03"; in line 22, strike "TWICE" and substitute "FIVE TIMES"; and in the same line, strike "10–YEAR" and substitute "5–YEAR".

On page 5, strike in their entirety lines 17 and 18; in lines 19, 22, 26, and 27, strike "(C)", "(D)", "(F)", and "(G)", respectively, and substitute "(B)", "(C)", "(D)", and "(E)", respectively; in line 22, strike "STATE-FUNDED PROJECT" and substitute "PUBLIC WORK CONTRACT SUBJECT TO SUBTITLE 2 OF THIS TITLE"; strike in their entirety lines 24 and 25; and in line 28, strike "EMPLOYED TO LEARN A SKILLED TRADE THROUGH" and substitute "ENROLLED IN".

On pages 5 and 6, strike in their entirety the lines beginning with line 27 on page 5 through line 12 on page 6, inclusive, and substitute:

"(E) "REGISTERED APPRENTICESHIP PROGRAM" MEANS AN APPRENTICESHIP PROGRAM REGISTERED WITH THE DIVISION OF WORKFORCE DEVELOPMENT AND ADULT LEARNING WITHIN THE DEPARTMENT.";

On page 6, in line 13, strike "(I)" and substitute "(F)"; strike in their entirety lines 15 through 17, inclusive, and substitute:

- "(A) EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION, THIS SUBTITLE APPLIES ONLY TO:
- (1) CONTRACTORS AWARDED A STATE CONTRACT THAT IS A COVERED LARGE PROJECT; AND
  - (2) COVERED LARGE PROJECTS LOCATED IN:
    - (I) ANNE ARUNDEL COUNTY;
    - (II) BALTIMORE CITY;
    - (III) BALTIMORE COUNTY;
    - (IV) HOWARD COUNTY;
    - (V) MONTGOMERY COUNTY; AND
    - (VI) PRINCE GEORGE'S COUNTY.
- (B) THIS SUBTITLE DOES NOT APPLY TO A STATE CONTRACT FOR WHICH THE FEDERAL GOVERNMENT PROVIDES MONEY.";

in line 20, strike "SMALL" and substitute "<u>LARGE</u>"; and strike beginning with the colon in line 20 down through "(2)" in line 23 and substitute a comma.

On pages 6 and 7, strike in their entirety the lines beginning with line 25 on page 6 through line 8 on page 7, inclusive.

On page 7, in line 9, strike "(C)" and substitute "(B)"; in line 15, after "CONTRACTOR" insert ", AS AN ALTERNATIVE TO FULFILLING THE REQUIREMENTS OF § 17–6B–03 OF THIS SUBTITLE,"; in the same line, after the third "TO" insert ":

# (1) THE STATE APPRENTICESHIP TRAINING FUND ESTABLISHED UNDER § 17–602 OF THIS TITLE; OR

**(2)**";

in line 16, after "PROGRAM" insert "OPERATING AND TRAINING APPRENTICES IN THE STATE"; strike beginning with "AS" in line 16 down through "SUBTITLE" in line 17; after line 23, insert:

"A CONTRACTOR THAT EXCEEDS THE REQUIREMENTS OF § 17–6B–03(A) OF THIS SUBTITLE ON A CONTRACT MAY APPLY THE EXCESS APPRENTICESHIP HOURS TO ANOTHER CONTRACT SUBJECT TO THIS SUBTITLE THAT IS ENTERED INTO BY THE CONTRACTOR WITHIN 2 YEARS AFTER THE COMPLETION OF THE FIRST CONTRACT.

and strike beginning with "**0.125**%" in line 25 down through "FAILS" in line 27, inclusive, and substitute "<u>TWICE THE NUMBER OF APPRENTICE HOURS AT THE APPRENTICE RATE BY WHICH THE CONTRACTOR FAILED</u>".
