AMENDMENTS TO HOUSE BILL 1207 (First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, after "**Education** –" insert "<u>Student Member</u>"; and in lines 4 and 5, in each instance, strike "members" and substitute "<u>student member</u>".

AMENDMENT NO. 2

On page 1, in lines 18 and 19, in each instance, strike the bracket.

On pages 1 and 2, strike beginning with "ANNUALLY" in line 19 on page 1 down through "OR" in line 2 on page 2.

On page 2, in lines 6 and 7, in each instance, strike the bracket; strike beginning with "ANNUALLY" in line 7 down through "OR" in line 11; and strike beginning with the bracket in line 21 down through "board" in line 31 and substitute "<u>:</u>

(I) MAY BE REIMBURSED FOR OUT-OF-POCKET EXPENSES INCURRED IN CONNECTION WITH OFFICIAL DUTIES; AND

(II) <u>SHALL BE GRANTED COMPENSATION IN ACCORDANCE</u> WITH PARAGRAPH (2) OF THIS SUBSECTION.

(2) (I) SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, THE COMPENSATION AMOUNT OF THE STUDENT MEMBER IS EQUAL TO THE HIGHEST ANNUAL RESIDENT UNDERGRADUATE TUITION, MANDATORY FEES, AND ROOM AND BOARD THAT IS CHARGED AT A 4-YEAR PUBLIC INSTITUTION OF HIGHER EDUCATION WITHIN THE UNIVERSITY SYSTEM OF MARYLAND, OTHER THAN THE UNIVERSITY OF MARYLAND GLOBAL CAMPUS AND UNIVERSITY OF MARYLAND, BALTIMORE CAMPUS, FOR THE ACADEMIC YEAR IN WHICH THE STUDENT MEMBER SERVES ON THE COUNTY BOARD.

(II) 1. SUBJECT TO SUBSUBPARAGRAPH 2 OF THIS **ELECT** SUBPARAGRAPH, THE STUDENT MEMBER MAY TO RECEIVE COMPENSATION **GRANTED UNDER** SUBSECTION IN THIS MONTHLY INSTALLMENTS AS A STIPEND DURING THE STUDENT MEMBER'S TERM AND RECEIVE ANY REMAINING AMOUNT AS A SCHOLARSHIP AFTER THE END OF THE TERM".

On page 3, in line 1, strike "a scholarship" and substitute "<u>COMPENSATION</u>"; strike beginning with the bracket in line 3 down through "term" in line 21; and in line 22, strike "3." and substitute "<u>2.</u>".
