<u>AMENDMENTS TO HOUSE BILL 328</u> (First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike "**Delegate Ebersole**" and substitute "**Delegates Ebersole, Griffith, and Vogel**"; and in line 13, after "locations;" insert "<u>altering certain requirements concerning the conduct of gaming through instant ticket lottery machines;</u>".

AMENDMENT NO. 2

On page 3, after line 22, insert:

"(III) AS A RETAILER UNDER THE INSTANT TICKET LOTTERY MACHINE PROGRAM, A VETERANS' ORGANIZATION OR FRATERNAL ORGANIZATION SHALL BE COMPENSATED BASED ON A PERCENTAGE OF PROCEEDS.";

in line 25, after "shall" insert "<u>RETAIN 50% OF THE NET PROCEEDS AND</u>"; and in the same line, strike "receipts" and substitute "<u>NET PROCEEDS</u>".

On page 4, in line 3, strike "**50% TO VETERANS' ORGANIZATIONS**" and substitute "<u>**5% TO THE MARYLAND VETERANS TRUST FUND ESTABLISHED UNDER**</u> <u>**§ 9–913 OF THIS TITLE**</u>"; strike beginning with "**REMIT**" in line 11 down through "**MACHINES**" in line 12 and substitute "<u>:</u>

1. <u>RETAIN 25% OF THE NET PROCEEDS FOR</u> <u>UNDERGRADUATE, GRADUATE, OR TRADE SCHOOL SCHOLARSHIPS OR CAPITAL</u> <u>IMPROVEMENTS, CAPITAL OUTLAYS, ACQUISITIONS, OR EXISTING COMMUNITY</u> <u>OUTREACH PROGRAMS AND RESOURCES; AND</u>

<u>2.</u> <u>**REMIT THE REMAINDER**</u>";

and in line 27, strike "AND".

On pages 4 and 5, strike in their entirety the lines beginning with line 28 on page 4 through line 2 on page 5, inclusive, and substitute:

"2. <u>5% to the Maryland Veterans Trust Fund</u> ESTABLISHED UNDER § 9–913 OF THIS TITLE;".

On page 5, in lines 3 and 6, strike "**B**." and "**C**.", respectively, and substitute "<u>3</u>." and "<u>4</u>.", respectively; in line 11, strike "receipts" and substitute "<u>NET PROCEEDS</u>"; strike beginning with "consistent" in line 27 down through "be" in line 28 and substitute "<u>CONTAINED</u>"; in line 28, strike "pre-printed" and substitute "<u>PREDETERMINED</u>"; and in line 30, strike "being wholly within the pre-printed instant lottery ticket".
