AMENDMENT NO. 1

On page 1, in the sponsor line, strike "**Delegates Stein, Allen, Cardin, and Pasteur**" and substitute "<u>Baltimore County Delegation</u>"; in line 3, strike "**Subdivisions and**"; in line 4, after "prohibiting" insert "<u>, for a certain period of time</u>,"; in lines 5 and 6 and 7, in each instance, strike "certain residential areas" and substitute "<u>a certain residential community</u>"; and in line 6, after "authorizing" insert "<u>, for a certain</u> <u>period of time</u>,".

AMENDMENT NO. 2

On page 1, in line 19, after "(c)" insert "<u>(1)</u>"; in the same line, strike "**BALTIMORE COUNTY AND**"; in line 20, strike the brackets; in lines 20 and 21, strike "THE COUNTY"; and after line 22, insert:

"(2) IN BALTIMORE COUNTY, BEGINNING OCTOBER 1, 2025, THROUGH THE END OF JUNE 30, 2028, A POLICE OFFICER MAY ENFORCE THE PROVISIONS OF THE MARYLAND VEHICLE LAW ON A PRIVATE ROADWAY WITHIN THE QUEEN ANNE VILLAGE COMMUNITY IN OWINGS MILLS THAT IS USED FOR VEHICULAR TRAFFIC BY RESIDENTS OF THE COMMUNITY.".

On page 2, in line 2, strike "any" and substitute ":

<u>(I)</u> <u>ANY</u>";

in the same line, strike the first comma and substitute a semicolon; strike beginning with ", in" in line 2 down through "any" in line 3 and substitute:

"<u>(II)</u> <u>ANY</u>";

in line 3, after "within" insert ":

<u>**1.**</u> <u>**IN CALVERT COUNTY,**";</u>

in line 4, after "community" insert "<u>; OR</u>

<u>2.</u> <u>IN BALTIMORE COUNTY, BEGINNING OCTOBER 1,</u> 2025, THROUGH THE END OF JUNE 30, 2028, THE QUEEN ANNE VILLAGE <u>COMMUNITY IN OWINGS MILLS</u>";

after line 4, insert:

"SECTION 2. AND BE IT FURTHER ENACTED, That, on or before September 1, 2028, the Baltimore County Police Department shall report to the members of the Baltimore County Delegation to the General Assembly, in accordance with § 2–1257 of the State Government Article, on the implementation of this Act and whether it has improved compliance with the Maryland Vehicle Law in the Queen Anne Village community in Owings Mills.";

in line 5, strike "2." and substitute "<u>3.</u>"; and in line 6, after "2025." insert "<u>It shall remain</u> <u>effective for a period of 3 years and, at the end of September 30, 2028, this Act, with no</u> <u>further action required by the General Assembly, shall be abrogated and of no further</u> <u>force and effect.</u>".
