- (VI) REVIEW AND COMMENT ON DRAFT REGULATIONS
  RELEVANT TO THE IMPLEMENTATION OF THE MATTRESS STEWARDSHIP
  PROGRAM.
- (2) THE ADVISORY BOARD SHALL MEET AT LEAST QUARTERLY UNTIL THE INITIAL ROUND OF STEWARDSHIP PLANS HAVE BEEN APPROVED, AND SEMIANNUALLY OR ANNUALLY, AS DETERMINED BY THE DEPARTMENT, THEREAFTER.
- (3) THE ADVISORY BOARD SHALL ELECT A CHAIR FROM AMONG THE MEMBERS BY A SIMPLE MAJORITY VOTE.
- (4) THE ADVISORY BOARD MAY ADOPT BYLAWS AND A CHARTER FOR THE OPERATION OF THE ADVISORY BOARD'S BUSINESS IN ACCORDANCE WITH THIS PART.
- (5) THE DEPARTMENT SHALL PROVIDE STAFF FOR THE ADVISORY BOARD.
- (6) ON OR BEFORE APRIL 1, 2027, THE ADVISORY BOARD SHALL REPORT, AND IF APPLICABLE SUBMIT A MINORITY REPORT ON, ITS FINDINGS AND RECOMMENDATIONS, IN ACCORDANCE WITH § 2–1257 OF THE STATE GOVERNMENT ARTICLE, TO THE GENERAL ASSEMBLY.

#### SECTION 3. AND BE IT FURTHER ENACTED, That:";
