On page 2, in line 20, strike "VISA" and substitute "<u>NONIMMIGRANT STATUS</u> <u>PETITION</u>"; in line 23, strike "§ 1184(O)" and substitute "§ 1184(P)"; in line 24, strike "<u>AND 245.24</u>" and substitute "<u>, 8 C.F.R. § 245.24</u>"; and in line 30, strike "VISA" and substitute "<u>NONIMMIGRANT STATUS PETITION</u>".

On page 3, in line 9, after the second comma insert "<u>or</u>"; in the same line, strike the third comma; strike beginning with "<u>CONVICTION</u>" in line 9 down through "<u>SENTENCING</u>" in line 10; in lines 14 and 18, in each instance, after the first comma insert "<u>or</u>"; in the same lines, in each instance, strike the second comma; in the same lines, in each instance, strike "<u>CONVICTION, OR SENTENCING</u>"; in line 33, strike "<u>THERE IS A REBUTTABLE PRESUMPTION THAT</u>"; and in line 34, after "friend" insert "<u>is assisting, has assisted, or is likely to assist law enforcement authorities in the</u> <u>detection, investigation, or prosecution of qualifying criminal activity, the victim or the</u> <u>victim's parent, guardian, or next friend shall be considered to be helpful, to have been</u> <u>helpful, or likely to be helpful.</u>".

On page 4, strike in their entirety lines 1 through 7, inclusive; in line 12, after "investigated" insert a comma; in line 13, strike the brackets; in the same line, strike the first comma; in the same line, strike ", <u>CONVICTED</u>, OR SENTENCED"; in line 15, after the second comma insert "<u>or</u>"; in the same line, strike the third comma; in line 16, strike "<u>CONVICTION, OR SENTENCING</u>"; strike beginning with "<u>PARAGRAPHS</u>" in line 19 down through "<u>(4)</u>" in line 20 and substitute "<u>paragraph (2)</u>"; and in line 26, strike "14" and substitute "<u>7</u>".

On pages 4 and 5, strike in their entirety the lines beginning with line 27 on page 4 through line 2 on page 5, inclusive.

On page 6, in line 4, strike "A U OR A T VISA" and substitute "<u>U</u> <u>NONIMMIGRANT STATUS</u>"; in line 10, after "HELPFUL" insert "<u>, IS BEING HELPFUL</u>, <u>OR IS LIKELY TO BE HELPFUL</u>"; and in line 14, strike "OR A T VISA APPLICATION" and substitute "<u>NONIMMIGRANT STATUS PETITION</u>".
