AMENDMENT NO. 1

On page 1, in line 6, strike "analyses" and substitute "<u>information in its</u> <u>application</u>"; and in line 7, strike "alternatives" and substitute "<u>evidence</u>".

AMENDMENT NO. 2

On page 2, in line 5, after "LINE" insert "FACILITY".

On page 5, strike beginning with "AN" in line 34 down through "INCLUDING" in line 35 and substitute "EVIDENCE THAT THE APPLICANT CONSIDERED, AS PART OF THE APPLICANT'S INTERNAL PLANNING PROCESS, ANY LOCAL, STATE, OR FEDERAL GOVERNMENT TRANSMISSION PLANNING PROCESSES, AND ANY TRANSMISSION PLANNING PROCESSES REQUIRED BY PJM INTERCONNECTION, LLC, INCLUDING".

On page 6, in lines 1 and 2, strike "THE USE OF ADVANCED TRANSMISSION TECHNOLOGIES" and substitute "ALTERNATIVES TO THE PROPOSED TRANSMISSION LINE;

B. AN ANALYSIS OF ADVANCED TRANSMISSION
TECHNOLOGIES AND WHETHER THE USE OF THE TECHNOLOGIES COULD DELAY
OR PREVENT THE NEED FOR FUTURE TRANSMISSION OR GENERATION
UPGRADES";

in lines 3, 4, 7, 8, 9, 10, 11, and 14, strike "B.", "C.", "D.", "E.", "F.", "G.", "H.", and "I.", respectively, and substitute "C.", "D.", "E.", "F.", "G.", "H.", "I.", and "J.", respectively; and in line 15, after "APPROPRIATE;" insert "AND".

On pages 6 and 7, strike beginning with the semicolon in line 24 on page 6 down through "UPGRADES" in line 3 on page 7.

On page 8, strike beginning with "ANY" in line 7 down through "OF" in line 9 and substitute "EVIDENCE THAT"; in line 9, strike "CONDUCTED" and substitute "HAVE BEEN CONSIDERED"; in line 10, strike "UNDER" and substitute "IN ACCORDANCE WITH"; strike beginning with "(IV)" in line 11 down through "PROCEEDINGS;" in line 12; and in line 13, strike "(V)" and substitute "(III)".

On page 9, in line 3, strike "ON" and substitute "(1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, ON"; in the same line, strike "2025" and substitute "2026"; in the same line, strike "2" and substitute "4"; in lines 6, 10, 12, 15, 17, 18, and 20, strike "(1)", "(2)", "(3)", "(4)", "(3)", "(5)", and "(1)", respectively, and substitute "(1)", "(III)", "(III)", "(III)", "(V)", and "(I)", respectively; in lines 17 and 20, in each instance, strike "SUBSECTION" and substitute "PARAGRAPH"; after line 20, insert:

"(2) THE COMMISSION MAY MODIFY THE REPORTING SCHEDULE SPECIFIED IN PARAGRAPH (1) OF THIS SUBSECTION.":

in line 24, after "(D)" insert "(1)"; and after line 28, insert:

"(2) IF AN OWNER OR OPERATOR OF AN OVERHEAD TRANSMISSION LINE USES ADVANCED TRANSMISSION TECHNOLOGIES AS A RESULT OF INFORMATION REPORTED UNDER THIS SECTION, THE COMMISSION MAY CONSIDER REASONABLE METHODS TO PROVIDE FINANCIAL INCENTIVES FOR THE USE OF ADVANCED TRANSMISSION TECHNOLOGIES UNDER THIS SECTION."
