BY repealing and reenacting, with amendments, Article – Transportation Section 21-707 and 21-1202 Annotated Code of Maryland (2020 Replacement Volume and 2024 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: **Article – Transportation** 21 - 707.[Unless] EXCEPT AS PROVIDED IN SUBSECTION (C-1) OF THIS SECTION, AND UNLESS otherwise directed by a police officer or traffic control signal, the driver of a vehicle approaching a stop sign at an intersection shall stop at the near side of the

- 32 (a) Every person operating a bicycle or a motor scooter in a public bicycle area 33 has all the rights granted to and is subject to all the duties required of the driver of a vehicle
