BY repealing and reenacting, with amendments. Article – Natural Resources Section 4-216, 4-604, and 4-614 Annotated Code of Maryland (2023 Replacement Volume and 2024 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND. That the Laws of Maryland read as follows: Article - Natural Resources 4-216.The Department shall establish a resident consolidated senior sport fishing license, to be issued to residents of Maryland beginning in the calendar year in which they attain the age of 65. (b) **(1)** The resident consolidated senior sport fishing license may be obtained from the Department or from any authorized agent of the Department.
