Annotated Code of Maryland
(2023 Replacement Volume and 2024 Supplement)

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

Article – Health – General

13–4502.

(a) There is a Cannabis Public Health Advisory Council.

(b) The Advisory Council consists of the following members:

(1) One member from the Senate of Maryland, appointed by the President
of the Senate;

(2) One member from the House of Delegates, appointed by the Speaker of
the House;

(3) The Secretary, or the Secretary’s designee;

(4) The Deputy Secretary for Behavioral Health, or the Deputy Secretary’s
designee;

(5) The Secretary of Agriculture, or the Secretary’s designee;

(6) The ~~Executive~~ Director of the [Natalie M. LaPrade Medical Cannabis
Commission] **MARYLAND CANNABIS ADMINISTRATION**, or the ~~Executive~~ Director’s
designee;

(7) The State Superintendent of Schools, or the State Superintendent’s
designee;

(8) The Executive Director of the Governor’s Office of Crime Prevention
and Policy, or the Executive Director’s designee; [and]

(9) **THE ADMINISTRATOR OF THE MOTOR VEHICLE
ADMINISTRATION, OR THE ADMINISTRATOR’S DESIGNEE; AND**

**(10) THE EXECUTIVE DIRECTOR OF THE OFFICE OF SOCIAL EQUITY IN
THE MARYLAND CANNABIS ADMINISTRATION, OR THE EXECUTIVE DIRECTOR’S
DESIGNEE; AND**

(11) The following members appointed by the Governor:

- 1 (i) One representative from a historically black college or
2 university;
- 3 (ii) One health care provider with experience in cannabis;
- 4 (iii) One pharmacist licensed in the State;
- 5 (iv) One health care provider with expertise in substance use
6 disorder treatment and recovery;
- 7 (v) One individual with expertise in cannabis use disorder;
- 8 (vi) One academic researcher with expertise in cannabis law and
9 policy;
- 10 (vii) One individual with at least 5 years of experience in health or
11 social equity;
- 12 (viii) One public health professional with cannabis experience; and
- 13 (ix) One representative of a laboratory that tests cannabis.

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
15 October 1, 2025.
