1 (a) (1) In this section the following words have the meanings indicated. 2 (2)"Facilities" means hospitals and related institutions whose rates have 3 been approved by the Commission. The Commission shall assess and collect user fees on facilities as defined in 4 (b) 5 this section. 6 (c) (1) The total fees assessed by the Commission may not exceed the greater 7 of: 8 (i) 0.1% of the immediately preceding fiscal year's budgeted, 9 regulated, gross hospital revenue; or 10 (ii) The largest amount determined under this paragraph for a fiscal 11 year during the immediately preceding 5 fiscal years. 12 The total user fees assessed by the Commission may not exceed the 13 Special Fund appropriation for the Commission by more than 20%. The user fees assessed by the Commission shall be used exclusively to 14 (3)15 cover the actual documented direct costs of fulfilling the statutory and regulatory duties of 16 the Commission in accordance with the provisions of this subtitle and any administrative 17 costs for services to the Commission provided by the Department. 18 The Commission shall pay all funds collected from fees assessed in 19 accordance with this section into the Health Services Cost Review Commission Fund. 20 The user fees assessed by the Commission may be expended only for 21purposes authorized by the provisions of this subtitle. 22The amount specified in paragraph (1) of this subsection limits only the 23total user fees the Commission may assess in a fiscal year. 24Chapter 696 of the Acts of 2022 25 SECTION 3.
