6 Act is required to be provided; and generally relating to the Maryland Trust
7 Decanting Act.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Estates and Trusts**

16 **14–602.1.**

17 **(A) NOTICE TO A PERSON UNDER THIS SUBTITLE OR THE SENDING OF A**
18 **DOCUMENT TO A PERSON UNDER THIS SUBTITLE SHALL BE ACCOMPLISHED IN A**
19 **MANNER REASONABLY SUITABLE UNDER THE CIRCUMSTANCES AND LIKELY TO**
20 **RESULT IN RECEIPT OF THE NOTICE OR DOCUMENT.**

21 **(B) AN AUTHORIZED FIDUCIARY SHALL PROVIDE NOTICE TO A PERSON**
22 **UNDER THIS SUBTITLE:**

2 **(2) BY CERTIFIED MAIL OR FIRST-CLASS MAIL, POSTAGE PREPAID,**
3 **RETURN RECEIPT REQUESTED;**

4 **(3) BY COURIER DELIVERY SERVICE, DELIVERY SERVICE PREPAID,**
5 **DELIVERY CONFIRMATION REQUESTED; OR**

6 **(4) IF A PERSON ENTITLED TO RECEIVE NOTICE UNDER THIS**
7 **SUBTITLE AGREES IN WRITING TO ACCEPT AN ALTERNATIVE FORM OF NOTICE:**

8 **(I) BY FIRST-CLASS MAIL, POSTAGE PREPAID;**

9 **(II) BY FACSIMILE TRANSMISSION FROM A FACSIMILE DEVICE**
10 **THAT PRODUCES A CONFIRMATION PAGE THAT SPECIFIES THE DATE AND TIME OF A**
11 **SUCCESSFUL FACSIMILE TRANSMISSION; OR**

12 **(III) BY E-MAIL, ACKNOWLEDGEMENT REQUESTED.**

13 **(C) (1) A PERSON MAY REVOKE THE AUTHORIZED FIDUCIARY'S**
14 **AUTHORIZATION TO PROVIDE NOTICE BY AN ALTERNATIVE METHOD UNDER**
15 **SUBSECTION (B)(4) OF THIS SECTION BY PROVIDING NOTICE TO THE AUTHORIZED**
16 **FIDUCIARY IN A METHOD SPECIFIED UNDER SUBSECTION (B)(1) THROUGH (3) OF**
17 **THIS SECTION.**

18 **(2) AN AUTHORIZED FIDUCIARY AUTHORIZED TO PROVIDE NOTICE BY**
19 **AN ALTERNATIVE METHOD UNDER SUBSECTION (B)(4) OF THIS SECTION MAY**
20 **CONTINUE TO PROVIDE NOTICE BY THE AUTHORIZED ALTERNATIVE METHOD UNTIL**
21 **THE PERSON ENTITLED TO RECEIVE NOTICE REVOKES THE AUTHORIZATION IN**
22 **ACCORDANCE WITH PARAGRAPH (1) OF THIS SUBSECTION.**

23 **(D) IF AN AUTHORIZED FIDUCIARY WHO PROVIDES NOTICE BY AN**
24 **ALTERNATIVE METHOD UNDER SUBSECTION (B)(4) OF THIS SECTION KNOWS OR**
25 **SHOULD KNOW THAT THE PERSON ENTITLED TO RECEIVE NOTICE DID NOT**
26 **ACTUALLY RECEIVE NOTICE, THE AUTHORIZED FIDUCIARY SHALL PROVIDE NOTICE**
27 **TO THE PERSON BY A METHOD SPECIFIED UNDER SUBSECTION (B)(1) THROUGH (3)**
28 **OF THIS SECTION.**

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
30 October 1, 2025.
