BY repealing and reenacting, with amendments, Article – Election Law Section 10–310(a) Annotated Code of Maryland (2022 Replacement Volume and 2024 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Election Law 10 - 310.For each individual who seeks to vote, an election judge, in accordance with instructions provided by the local board, shall: locate the individual's name in the election register and locate the preprinted voting authority card and then authorize the individual to vote a regular ballot; (2)if the individual's name is not found on the election register, search the inactive list and if the name is found, authorize the individual to vote a regular
