1 AN ACT concerning

2 **Electric Companies – Regional Transmission Organizations – Report**
3 **(Utility Transparency and Accountability Act)**

4 FOR the purpose of requiring a certain electric company to submit an annual report to the
5 Public Service Commission regarding each recorded vote cast by the electric company
6 and any State affiliate of the electric company at a meeting of a regional transmission
7 organization; and generally relating to electric companies and regional transmission
8 organizations.

9 BY adding to

11 Section 7–108
12 Annotated Code of Maryland
13 (2020 Replacement Volume and 2024 Supplement)

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Public Utilities**

17 **7–108.**

18 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
19 **INDICATED.**

1 (2) “AFFILIATE” HAS THE MEANING STATED IN § 7-501 OF THIS
2 TITLE.

3 (3) “MEETING” MEANS ANY COMMITTEE, USER GROUP, TASK FORCE,
4 OR OTHER PART OF THE REGIONAL TRANSMISSION ORGANIZATION IN WHICH VOTES
5 ARE TAKEN.

6 (4) “RECORDED VOTE” MEANS A VOTE THAT IS TABULATED, EITHER
7 INDIVIDUALLY OR AS PART OF A SECTOR, FOR ANY PURPOSE AT A MEETING,
8 REGARDLESS OF:

9 (I) WHETHER THE VOTE REPRESENTS A FINAL POSITION OF
10 ANY PERSON CASTING THE VOTE; OR

11 (II) THE DECISION-MAKING AUTHORITY OF THOSE VOTING.

12 (5) “REGIONAL TRANSMISSION ORGANIZATION” MEANS AN ENTITY
13 THAT QUALIFIES AS A REGIONAL TRANSMISSION ORGANIZATION UNDER 18 C.F.R. §
14 35.34.

15 (B) THIS SECTION DOES NOT APPLY TO A MUNICIPAL ELECTRIC UTILITY.

16 (C) (1) ON OR BEFORE FEBRUARY 1 EACH YEAR, EACH ELECTRIC
17 COMPANY SHALL SUBMIT TO THE COMMISSION A REPORT ON EACH RECORDED VOTE
18 CAST BY THE ELECTRIC COMPANY OR, SUBJECT TO PARAGRAPH (2) OF THIS
19 SUBSECTION, ~~AN~~ A STATE AFFILIATE OF THE ELECTRIC COMPANY AT A MEETING OF
20 A REGIONAL TRANSMISSION ORGANIZATION DURING THE IMMEDIATELY PRECEDING
21 CALENDAR YEAR.

22 (2) THE REPORT SHALL INCLUDE:

23 (I) ALL RECORDED VOTES CAST BY THE ELECTRIC COMPANY,
24 REGARDLESS OF WHETHER THE VOTE IS OTHERWISE DISCLOSED; AND

25 (II) ALL VOTES CAST BY ~~AN~~ A STATE AFFILIATE OF THE
26 ELECTRIC COMPANY IF THE ELECTRIC COMPANY ITSELF DOES NOT VOTE ON THE
27 MATTER.

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
29 October 1, 2025.
