A BILL ENTITLED

1 AN ACT concerning

2 **State Department of Assessments and Taxation – Notification of Constant Yield**
3 **Tax Rate – Repeal**

4 FOR the purpose of repealing the requirement that the State Department of Assessments
5 and Taxation notify each taxing authority of the constant yield tax rate for each
6 taxable year; and generally relating to the constant yield tax rate.

7 BY repealing and reenacting, without amendments,

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Tax – Property**

20 2–205.

21 (a) In this section, “taxing authority” means:

22 (1) the county council or board of county commissioners of a county;

1 (2) the City Council of Baltimore City; and

2 (3) the governing body of a municipal corporation.

3 [(c) (1) The Department shall notify each taxing authority of the constant yield
4 tax rate that will provide the same property tax revenue that is provided by the real
5 property tax rate that is in effect for the current taxable year.

6 (2) In calculating a constant yield tax rate for a taxable year, the
7 Department shall use an estimate of the total assessment of all real property for the next
8 taxable year exclusive of real property that appears for the 1st time on the assessment
9 records.

10 (3) (i) The Department may amend a constant yield tax rate only as
11 provided in this paragraph.

12 (ii) On or before April 15 each year, the Department may amend a
13 constant yield tax rate when a county or municipal corporation alters the homestead tax
14 credit percentage under § 9–105 of this article.

15 (iii) On or before May 15 each year, the Department may amend a
16 constant yield tax rate:

17 1. when directed to make a change by an enactment of the
18 General Assembly;

19 2. to correct an error in the calculation of the constant yield
20 tax rate; or

21 3. to reflect a significant loss of taxable base, as determined
22 by the Director.]

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
24 1, 2025.
