#### State Government – Veterans – Burial at State Veterans' Cemeteries (Burial Equity Act)

FOR the purpose of expanding eligibility for burial in a State veterans' cemetery to include
members of the National Guard and the military reserves a reserve component;
removing the residency requirement for certain veterans for burial in a State
veterans' cemetery; establishing a burial fee for National Guard and military
reserves service reserve component members and their eligible dependents; and
generally relating to burial at State veterans' cemeteries.
