4 FOR the purpose of ~~requiring the Commissioner of Labor and Industry to appoint an~~
5 ~~Assistant Commissioner for Public Employees’ Safety and Health for certain~~
6 ~~purposes~~; requiring the Correctional Training Commission to adopt certain
7 regulations for the training, issuance, and use of body-worn cameras; requiring each
8 correctional unit to develop and maintain a certain written policy for the use of
9 body-worn cameras by correctional officers, subject to a certain exception;
10 establishing that it is lawful for a correctional officer to intercept certain
11 communications by use of a body-worn camera under certain circumstances;
12 establishing the Public Employees’ Safety and Health Unit in the Division of Labor
13 and Industry to administer and enforce certain provisions regarding the oversight of
14 workplace safety and health of employees of certain public bodies; altering the
15 Maryland Occupational Safety and Health Act as it applies to certain public bodies;
16 repealing the prohibition on certain penalties being applied to public bodies;
17 requiring the Attorney General to provide certain notices and prioritize certain
18 requests for administrative warrants; requiring the revenues from certain civil
19 penalties to be used for the Maryland Apprenticeship and Training Program;
20 requiring the Commissioner of Labor and Industry, in consultation with the
21 Occupational Safety and Health Advisory Board, to adopt regulations that protect
22 employees of public bodies from workplace violence; and generally relating to ~~the~~
23 Maryland Occupational Safety and Health Act public employee safety and health.

28 OFFICER is making reasonable efforts to conform to standards in accordance with § 3-511
29 of the Public Safety Article OR § 8-211 OF THE CORRECTIONAL SERVICES ARTICLE for
30 the use of body-worn digital recording devices or electronic control devices capable of
31 recording video and oral communications;

32 3. The law enforcement officer OR CORRECTIONAL
33 OFFICER is a party to the oral communication;

1 4. Law enforcement OR THE CORRECTIONAL OFFICER
 2 notifies, as soon as is practicable, the individual that the individual is being recorded,
 3 unless it is unsafe, impractical, or impossible to do so; and

4 5. The oral interception is being made as part of a videotape
 5 or digital recording.

 7 not affect the admissibility in court of the recording if the failure to notify involved an
 8 individual who joined a discussion in progress for which proper notification was previously
 9 given.
