BY repealing and reenacting, without amendments, Article – Education Section 8–420(a) through (c) Annotated Code of Maryland (2022 Replacement Volume and 2024 Supplement) BY repealing and reenacting, with amendments, Article – Education Section 8–420(d) Annotated Code of Maryland (2022 Replacement Volume and 2024 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

"Program" means the Therapeutic Child Care Grant Program. 18 (3)19 (b) There is a Therapeutic Child Care Grant Program in the State. 20 (c) (1)The purpose of the Program is to provide grants to providers that 21specialize in providing child care and early childhood education to children under the age 22of 6 years who have developmental delays, physical disabilities, or delays in social, 23emotional, or behavioral functioning. 24(2)The Department shall administer the Program. 25(3)On or before August 15 each year, the Department shall award grants 26under this section. 27 For each of fiscal years 2023 through 2025, AND FOR FISCAL YEAR (d) (1) 28 **2027** AND EACH FISCAL YEAR THEREAFTER, the Governor shall include in the annual 29 budget bill an appropriation of \$3,700,000 to the Program.
