A BILL ENTITLED

1 AN ACT concerning

2 **State Government – Department of Veterans and Military Families – Board and**
3 **Commission – Membership and Oversight**

4 FOR the purpose of requiring the Department of Veterans and Military Families to provide
5 oversight of the War Memorial Building; altering the membership of the Maryland
6 Veterans Trust Fund Board of Trustees; altering the membership of the Maryland
7 Veterans Commission; repealing the War Memorial Commission; and generally
8 relating to the Department of Veterans and Military Families.

4 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
5 That Section(s) 9–932 through 9–939 and the part “Part IV. War Memorial Commission” of
6 Article – State Government of the Annotated Code of Maryland be repealed.

7 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
8 as follows:

9 **Article – State Government**

10 **9–908.1.**

11 **(A) THE DEPARTMENT SHALL PROVIDE OVERSIGHT OF THE WAR**
12 **MEMORIAL BUILDING AS PROVIDED IN THIS SECTION.**

13 **(B) (1) THE DEPARTMENT SHALL ADOPT REGULATIONS THAT PROVIDE**
14 **FOR THE MANAGEMENT OF THE WAR MEMORIAL BUILDING IN A MANNER THAT:**

15 **(I) PERMITS THE GREATEST POSSIBLE USE OF THE BUILDING**
16 **BY THE PEOPLE OF THE STATE AND BY PATRIOTIC ORGANIZATIONS IN THE STATE;**
17 **AND**

18 **(II) TO THE EXTENT POSSIBLE, PERMITS THE USE BY THE**
19 **PATRIOTIC ORGANIZATIONS WITHOUT COST.**

20 **(2) THE DEPARTMENT SHALL ENFORCE THE REGULATIONS.**

21 **(C) THE DEPARTMENT MAY USE, FOR THE MAINTENANCE AND**
22 **ADMINISTRATION OF THE BUILDING, ANY FUNDS THAT THE GENERAL ASSEMBLY OR**
23 **THE MAYOR AND CITY COUNCIL OF BALTIMORE APPROPRIATE FOR THOSE**
24 **PURPOSES.**

25 **(D) THE STATE AND BALTIMORE CITY JOINTLY SHALL HOLD TITLE TO THE**
26 **WAR MEMORIAL BUILDING AND THE MEMORIAL SITE.**

27 9–914.

28 (a) The powers and duties of the Trust shall rest in and be exercised by a Board
29 of Trustees.

30 (b) The Board of Trustees shall consist of the following 11 members:

- 1 (1) the Secretary, ex officio, or the Secretary's designee, who shall serve as
2 the chair;
- 3 (2) the Secretary of Aging, ex officio, or the Secretary's designee;
- 4 (3) the Secretary of Labor, ex officio, or the Secretary's designee;
- 5 (4) the Secretary of Health, ex officio, or the Secretary's designee;
- 6 (5) the Secretary of Human Services, ex officio, or the Secretary's designee;
- 7 (6) the Adjutant General of the Military Department, ex officio, or the
8 Adjutant General's designee;
- 9 (7) one representative of each of the following organizations, appointed by
10 the Governor:
- 11 (i) a veterans service organization;
- 12 (ii) a nonprofit organization that serves veterans; and
- 13 (iii) the business community;
- 14 (8) **AS A NONVOTING TRUSTEE**, a member of the House of Delegates
15 appointed by the Speaker of the House; and
- 16 (9) **AS A NONVOTING TRUSTEE**, a member of the Senate appointed by the
17 President of the Senate.
- 18 (c) The Governor shall consider geographical balance in making appointments to
19 the Board of Trustees.
- 20 (d) Except for the ex officio members or their designees:
- 21 (1) the term of a member is 4 years;
- 22 (2) the terms of members are staggered as required by the terms provided
23 for members of the Board on July 1, 2013;
- 24 (3) at the end of a term, a member continues to serve until a successor is
25 appointed and qualifies;
- 26 (4) a member who is appointed after a term has begun serves for the rest
27 of the term and until a successor is appointed and qualifies; and
- 28 (5) a member may serve no more than 2 terms.

2 (a) The Board shall meet at places and dates to be determined by the Board, but
3 not less than 2 times a year.

4 (b) A majority of the **VOTING** trustees is a quorum.

5 (c) A trustee:

6 (1) may not receive compensation as a trustee; but

7 (2) is entitled to reimbursement for expenses under the Standard State
8 Travel Regulations, as provided in the State budget.

9 (d) The Department shall provide staff, supplies, and office space for the Board.

11 In this Part II of this subtitle, “Commission” means the Maryland Veterans
12 Commission.

13 9–917.

14 (a) (1) The Commission consists of the following members appointed by the
15 Governor.

16 (2) Of the members:

17 (i) 1 shall be appointed **AS A NONVOTING MEMBER** from each [of
18 the 8 congressional districts in the State] **COUNTY VETERAN COMMISSION**;

19 (ii) 1 shall be a veteran appointed from the State at large;

20 (iii) 1 shall be a woman veteran appointed from the State at large;

21 (iv) 1 shall be a representative of a retired enlisted organization;

22 (v) 1 shall be a veteran of the Iraq or Afghanistan conflict, as defined
23 in § 1–202(a–1) of the Public Safety Article;

24 (vi) 1 shall be appointed from a list of individuals submitted to the
25 Governor by each of the following organizations:

26 [1. the American Ex–Prisoners of War, Inc.];

27 [2.] 1. the American Legion;

- 1 [3.] 2. the AMVETS;
- 2 [4.] 3. the Catholic War Veterans;
- 3 [5.] 4. the Disabled American Veterans;
- 4 [6.] 5. the Fleet Reserve Association;
- 5 [7.] 6. the Jewish War Veterans;
- 6 [8.] 7. the Marine Corps League;
- 7 [9.] 8. the Maryland Military Officers Association of America;
- 8 [10.] 9. the Military Order of the Purple Heart;
- 9 [11.] 10. the Polish Legion of American Veterans;]
- 10 [12.] 11. the Veterans of Foreign Wars;
- 11 [13.] 12. the Vietnam Veterans of America;
- 12 [14.] 13. the Korean War Veterans Association, Inc.;
- 13 [15.] 14. the National Association for Black Veterans;
- 14 [16.] 15. the Colonial Chapter of the Paralyzed Veterans of
15 America; and
- 16 [17.] 16. the Reserve Organization of America; and

17 (vii) [1 shall be an honorary nonvoting member appointed from a list
18 of individuals submitted to the Governor by the Pearl Harbor Survivors Association] **A**
19 **DESIGNEE FROM A MARYLAND NONPROFIT ORGANIZATION REPRESENTING**
20 **VETERANS AND MILITARY FAMILIES.**

21 (b) Each member must be a resident of the State and a veteran.

22 (c) (1) The term of an appointed member is 5 years.

23 (2) The terms of the appointed members are staggered as required by the
24 terms provided for members of the Commission on October 1, 1984.

25 (3) At the end of a term, a member continues to serve until a successor is
26 appointed and qualifies.

1 (4) A member who is appointed after a term has begun serves only for the
2 rest of the term and until a successor is appointed and qualifies.

3 (5) (I) When an organization is no longer a part of the Commission, the
4 appointment shall terminate at the end of the current member's term.

5 (II) AN ORGANIZATION'S REPRESENTATIVE SEAT MAY BE
6 REMOVED IF THE ORGANIZATION FAILS TO APPOINT A NEW COMMISSIONER FOR 2
7 CONTINUOUS YEARS.

8 (6) AN ORGANIZATION MAY BE REMOVED FROM THE COMMISSION IF
9 A REPRESENTATIVE FROM THE ORGANIZATION IS NOT RECOMMENDED BY THAT
10 ORGANIZATION.

11 (d) [A new organization may not be eligible for representation on the Commission,
12 by appointment of the Governor, unless it is congressionally chartered] A MAJORITY OF
13 THE VOTING MEMBERS OF THE COMMISSION IS A QUORUM.

14 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
15 October 1, 2025.
