BY adding to Article - Election Law Section 4–206 Annotated Code of Maryland (2022 Replacement Volume and 2024 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Election Law 4-206.THIS SECTION APPLIES ONLY TO THE PROCESS OF FILLING A VACANCY IN THE OFFICE OF SENATOR OR DELEGATE IN THE GENERAL ASSEMBLY UNDER ARTICLE III, § 13 OF THE MARYLAND CONSTITUTION.

- 1 (B) (1) THE APPLICATION PERIOD TO APPLY TO A CENTRAL COMMITTEE 2 TO FILL A VACANCY SHALL BE:
- 3 (I) OPEN FOR AT LEAST 7 DAYS; AND
- 4 (II) ADVERTISED IN A CONSPICUOUS MANNER BY THE CENTRAL
- 5 COMMITTEE FILLING THE VACANCY BY A PUBLIC NOTICE THAT INCLUDES:
- 6 1. THE CENTRAL COMMITTEE'S INTENT TO MEET TO FILL
- 7 THE VACANCY;
- 8 2. THE TIME AND PLACE OF ANY MEETINGS TO BE HELD
- 9 TO DISCUSS OR VOTE ON THE FILLING OF THE VACANCY;
- 10 3. THE PROCESS FOR FILLING THE VACANCY; AND
- 11 4. THE MANNER IN WHICH INDIVIDUALS MAY APPLY TO

- 23 (2) REMAIN POSTED ONLINE UNTIL AT LEAST 30 DAYS AFTER THE
- 24 CENTRAL COMMITTEE VOTES ON AN INDIVIDUAL TO FILL THE VACANCY.
- 25 (D) THE CENTRAL COMMITTEE SHALL HOLD A PUBLIC MEETING TO
- 26 INTERVIEW THE INDIVIDUALS WHO APPLIED TO FILL THE VACANCY.
- 27 (E) A MEETING HELD BY A CENTRAL COMMITTEE TO DISCUSS OR VOTE ON
