"Forensic genetic genealogical DNA analysis and search" or "FGGS" means: 1 (e)  $\mathbf{2}$ the forensic genetic genealogical DNA analysis of biological material (1)3 using SNP or other sequencing techniques to develop an FGG profile; 4 (2)a subsequent search using the FGG profile in a publicly available open-data personal genomics database or a direct-to-consumer genetic genealogy service  $\mathbf{5}$ 6 to find individuals related to the source of the FGG profile; and  $\overline{7}$ (3)a genealogical search using public records and other lawful means to 8 obtain information in accordance with this title. 9 17 - 102.10 FGGS may not be initiated without judicial authorization and without (a) (1)11 certifying before the court that the forensic sample and the criminal case satisfy the criteria 12set forth in this section. 13If an FGGS is certified before a court in accordance with this section, (2)the court shall authorize the initiation of the FGGS. 14A sworn affidavit shall be submitted by a law enforcement agent with approval 15(b)16 of a prosecutor from the relevant jurisdiction asserting that: 17(1) THE IDENTITY OF THE PERPETRATOR IS UNKNOWN; 18 **[**(1)**] (2)** the crime is the commission of, or the attempt to commit, murder, 19 rape, a felony sexual offense, or a criminal act involving circumstances presenting a 20substantial and ongoing threat to public safety or national security; 21**[**(2)**] (3)** the forensic sample to be subjected to the FGGS is biological 22material reasonably believed by investigators to have been deposited by a putative perpetrator and that the forensic sample was collected from: 2324(i) a crime scene; 25(ii) a person, an item, or a location connected to the criminal event; 26or 27(iii) the unidentified human remains of a suspected homicide victim; 28AND **[**(3)**] (4)** an STR DNA profile has already been developed from the forensic
