AN ACT concerning		
Task Force to Study Fiduciary Adjudication in Maryland		
FOR the purpose of establishing the Task Force to Study Fiduciary Adjudication in Maryland to examine and analyze the efficiency, uniformity, and quality of fiduciary adjudication in Maryland and make recommendations; requiring the orphans' courts, circuit courts, registers of wills, and Administrative Office of the Courts to comply with certain requests of the Task Force; and generally relating to the Task Force to Study Fiduciary Adjudication in Maryland.		
Preamble		
WHEREAS, In 2022, the Task Force to Study the Maryland Orphans' Courts issued a report identifying certain inefficiencies and other problems with the selection of judges for, and adjudication of matters before, the orphans' courts; and

WHEREAS, More recent developments have further illustrated those problems, including the lack of uniformity in probate adjudication across Maryland's jurisdictions; and

- WHEREAS, The adjudication of other fiduciary matters, including those relating to trusts and adult guardianships, involve overlapping issues with probate matters and can be more efficient; and
- WHEREAS, Maryland created the orphans' courts in 1777 in order to assist families with the transmission of wealth on a member's death; and
- 9 WHEREAS, In the ensuing 248 years, methods for holding and transmitting wealth 10 have changed significantly, and probate and fiduciary legal issues have become 11 substantially more complex; and
- WHEREAS, The General Assembly recognizes the value that a specialized court brings to families in times of transition; and
- WHEREAS, The General Assembly also recognizes the need for further changes to fiduciary adjudication in Maryland in order to provide a uniform and efficient system for its citizens; now, therefore,
- 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 18 That:
- 19 (a) There is a Task Force to Study Fiduciary Adjudication in Maryland.
- 20 (b) The Task Force consists of the following members:
- 21 (1) two members of the Senate of Maryland, appointed by the President of 22 the Senate:
- 23 (2) two members of the House of Delegates, appointed by the Speaker of 24 the House;
- 25 (3) two members who are judges of an orphans' court, at least one of whom 26 serves in a jurisdiction where orphans' court judges are required to be attorneys, appointed 27 by the chair of the Conference of Orphans' Court Judges;
- 28 (4) one <u>nonvoting</u> member who is a judge of the circuit court in a jurisdiction where the circuit court sits as the orphans' court, appointed by the Chief Justice of the Supreme Court of Maryland;
- 31 (5) two members of the Maryland State Bar Association, designated by the 32 <u>chair of the</u> Estate and Trust Law Section Council, <del>at least one of whom is</del> <u>who between</u> 33 <u>them shall include</u> a fiduciary litigator <u>and a resident of a jurisdiction with a population of</u> 34 less than 250,000;

the chair two registers of wills designated by the president of the 1 2 Maryland Register of Wills Association; and 3 one member with expertise in budgeting and personnel matters, 4 appointed by the Governor. 5 The Governor shall designate the chair of the Task Force from among the (c) 6 members appointed by the President of the Senate or the Speaker of the House. 7 The Administrative Office of the Courts Department of Legislative Services in (d) conjunction with the Maryland State Bar Association shall provide staff for the Task Force. 8 9 (e) A member of the Task Force:

may not receive compensation as a member of the Task Force; but

is entitled to reimbursement for expenses under the Standard State

- 14 (1) examine the qualifications, training, and methods of selection of judges 15 hearing probate and other fiduciary matters in Maryland;
- 16 (2) examine the jurisdictions of the orphans' courts and circuit courts with respect to fiduciary matters;
- 18 (3) analyze the efficiency of the procedures for adjudicating <del>fiduciary</del> 19 <u>contested and uncontested</u> matters in the orphans' courts and circuit courts;
- 20 (4) analyze the effect of the different qualifications of orphans' court judges 21 and related litigation procedures on the uniform application of justice in Maryland;
- 22 (5) analyze and compare the laws and practices of other states relating to 23 the adjudication of fiduciary matters, including the selection, qualification, and training of 24 judges hearing those matters;
- 25 (6) seek guidance from appropriate witnesses with experience or expertise 26 in the area of fiduciary adjudication;
- 27 (7) examine any other research, analysis, or guidance related to the best 28 practices for adjudicating fiduciary matters;
- 29 (8) offer one or more opportunities for members of the public and other 30 interested parties to give their opinions on the subjects considered by the Task Force; and

9 10 11 12	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2025. It shall remain effective for a period of 1 year and, at the end of June 30, 2026, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
6 7 8	(h) On or before January 1, 2026, the Task Force shall report its findings and recommendations to the Governor and, in accordance with § 2–1257 of the State Government Article, the General Assembly.
3 4 5	(g) The orphans' courts, circuit courts, registers of wills, and Administrative Office of the Courts shall comply with all reasonable requests by the Task Force for information and data the Task Force considers necessary for its work.
