- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
   That the Laws of Maryland read as follows:

21 (a) In this article the following words have the meanings indicated unless 22 otherwise apparent from context.

23 (b) "County" includes Baltimore City.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW. [Brackets] indicate matter deleted from existing law.



1 (c) "Deed" includes any deed, grant, mortgage, deed of trust, lease, assignment, 2 and release, pertaining to land or property or any interest therein or appurtenant thereto, 3 including an interest in rents and profits from rents.

4 (d) (1) "Deed of trust" means [only] a deed of trust [which] THAT secures a 5 debt or the performance of an obligation[, and].

6 (2) "DEED OF TRUST" does not include a voluntary grant unrelated to 7 security purposes.

8 (e) "Grant" includes conveyance, assignment, and transfer.

9 (f) "Land" [has the same meaning as "property"] MEANS PROPERTY.

10 (g) "Landlord" means any landlord, including a ["lessor"] LESSOR.

# 11 (H) "LAND RECORD" MEANS ANY DOCUMENT RECORDED BY A CLERK OF 12 THE CIRCUIT COURT AFFECTING THE TITLE TO PROPERTY.

[(h)] (I) "Lease" means any oral or written agreement, express or implied,
 creating a landlord and tenant relationship, including any ["sublease"] SUBLEASE and any
 further sublease.

16 [(i)] (J) "Mortgage" means any mortgage, including a deed in the nature of 17 mortgage.

18 **[(j)] (K)** "Person" includes an individual, A receiver, A trustee, A guardian, AN 19 executor, AN administrator, A fiduciary, or A representative of any kind, or any partnership, 20 firm, association, public or private corporation, or any other entity.

21 [(k)] (L) "Property" means real property or any interest [therein or appurtenant 22 thereto] IN REAL PROPERTY.

23 [(1)] (M) "Purchaser" [has the same meaning as] MEANS A buyer or vendee.

24 [(m)] (N) "Tenant" means any tenant including a ["lessee"] LESSEE.

25 [(n)] (O) "Vendor" [has the same meaning as] MEANS A seller.

27(a)(1)The [Clerk of the Circuit Court] CLERK OF THE CIRCUIT COURT may28record an instrument that effects a change of ownership if the instrument is:

If the deed or other instrument is wholly typewritten or typewritten on a printed 24form, the typewriting shall be in black letters, in not less than elite type and [upon] ON 25white paper of sufficient weight or thickness as to be clearly readable. The foregoing 26provisions do not apply to manuscript covers or backs customarily used on documents 27offered for recordation. The recording charge for any instrument not conforming to these 28requirements shall be [treble] THREE TIMES the normal [charge] AMOUNT CHARGED. In 29any clerk's office where the deeds or other instruments are [photostated or microfilmed] 30 SCANNED, no instrument on which a rider has been placed or attached in a manner 31obscuring, hiding, or covering any other part of the instrument may be offered or received 32for record. No instrument not otherwise readily subject to [photostating or microfilming] 33 SCANNING may be offered or received for record until [treble] THREE TIMES the normal 34recording charge is paid to the clerk and unless an affidavit, black type on white paper, is 35attached and made a part of the document stating the kind of instrument, the date, the 36 parties to the transaction, description of the property, and all other pertinent data; AND

9 (a) A mortgage or deed of trust may be released validly by any procedure 10 enumerated in this section or § 3–105.2 of this subtitle.

11 (b) (1) A release may be endorsed on the original mortgage or deed of trust by 12 the mortgagee or [his] AN assignee OF THE MORTGAGEE, the trustee or [his] A successor 13 OF THE TRUSTEE under a deed of trust, or by the holder of the debt or obligation secured 14 by the deed of trust.

15 (2) The mortgage or the deed of trust, with the endorsed release, then shall 16 be filed in the office in which the mortgage or deed of trust is recorded.

6 (4)**(I)** When the debt secured by a mortgage or deed of trust is fully paid 7or satisfied and the holder or the agent of the holder of the mortgage or deed of trust note 8 or other obligation secured by the deed of trust, or the trustee or successor trustee under 9 the deed of trust, executes and acknowledges a certificate of satisfaction substantially in the form specified under § 4–203(d) of this article, containing the name of the debtor, holder, 10 11 the authorized agent of the holder, or the trustee or successor trustee under the deed of 12trust, the date, and the land record recording reference of the instrument to be released, it 13may be received by the clerk and indexed and recorded as any other instrument in the 14nature of a release.

15 **(II)** The certificate of satisfaction shall have the same effect as a 16 release executed by the holder of a mortgage or the named trustee under a deed of trust.

17When the holder of a mortgage or deed of trust note or other **(I)** (5)18obligation secured by the deed of trust has agreed to release certain property from the lien 19of the mortgage or deed of trust and the holder or the agent of the holder of the mortgage 20or deed of trust note or other obligation secured by the deed of trust, or the trustee or 21successor trustee under the deed of trust executes and acknowledges a certificate of partial 22satisfaction or partial release substantially in the form specified under § 4-203(e) of this 23article, containing the name of the debtor, holder, the authorized agent of the holder, or the 24trustee or successor trustee under the deed of trust, the date, the land record recording 25reference of the instrument to be partially released, and a description of the real property 26being released, it may be received by the clerk and indexed and recorded as any other 27instrument in the nature of a partial release.

[(e)] (D) A release of a mortgage or deed of trust may be made on a separate instrument if it states that the mortgagee, holder of the debt or obligation secured by the deed of trust, trustee, or assignee releases the mortgage or deed of trust and states the names of the parties to the mortgage or deed of trust and the date and recording reference of the mortgage or deed of trust to be released. In addition, any form of release that satisfies the requirements of a deed and is recorded as required by this article is sufficient.

The clerk of the **CIRCUIT** court shall record [photographically] any assignment of a mortgage with an attachment or rider affixed to it containing the names of the parties as they appear on the original mortgage and a reference to the book number and page number where the mortgage is recorded.

1 (a) (1) Except as provided in paragraph (2) of this subsection, the provisions of 2 this section are in addition to any other provisions of the Code, pertaining to recordation of 3 subdivision plats.

4 (2) [The provisions of this] **THIS** section [do] **DOES** not apply in Queen 5 Anne's County.

6 (b) (1) If the owner of land in the State subdivides [his] THE land for 7 commercial, industrial, or residential use to be comprised of streets, avenues, lanes, or 8 alleys and lots, and desires, for the purpose of description and identification, to record a 9 plat of the subdivision among the land records of the county where the land lies, the clerk 10 of the court shall accept and record the plat as prescribed in this section.

11 (2) The clerk may not accept the plat for record until the owner of land 12 complies with the requirements prescribed in this section.

13 (c) (1) In this subsection, "coordinate" means a number which determines the 14 position of any point in a north or south and an east or west direction in relation to any 15 other point in the same coordinate system.

16 (2) The plat shall be legible, drawn accurately and to scale and shall be 17 submitted for recordation using black ink on transparent mylar[, or linen] or black-line 18 photo process comparable to original quality that will conform to archival standards. [The 19 State Highway Administration may substitute microfilm aperture cards showing property 20 or rights-of-way to be acquired or granted. Microfilm aperture cards must meet archival 21 standards for permanent records.]

(3) The plat shall contain the courses and distances of all lines drawn onthe plat.

(4) With respect to all curved lines, the plat shall show the length of allradii, arcs, and tangents and the courses and distances of all chords.

(5) The plat shall contain a north arrow which represents and designates
either true or magnetic meridian as of a date specified on the plat or shall be referenced to
a recognized coordinate system within the county.

(6) All courses shown on the plat shall be calculated from the plat meridian.

30 (7) No distance on the plat may be marked "more or less" except on lines 31 which begin, terminate, or bind on a marsh, stream, or any body of water.

32 (8) (1) The plat shall show the position by coordinates of not less than 33 four markers set in convenient places within the subdivision in a manner so that the 34 position of one marker is visible from the position of one other marker.

1 (II) From these markers, commonly called ["traverse points"] 2 TRAVERSE POINTS, every corner and line can be readily calculated and marked on the 3 ground.

4 (III) These markers shall comply with standards that the State Board 5 for Professional Land Surveyors sets by regulation under § 15–208 of the Business 6 Occupations and Professions Article.

7 (9) A certificate stating that the requirement of this subsection, as far as it 8 concerns the making of the plat and setting of the markers, shall be put on the plat and 9 signed by the owner of the land shown on the plat to the best of [his] THE OWNER'S 10 knowledge and by the professional land surveyor or property line surveyor preparing it.

11 (d) (1) [Three linen] THE OWNER SHALL MAIL OR DELIVER THREE copies 12 of the plat [shall be mailed or delivered] to the clerk.

13(2)(I)[The] EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS14PARAGRAPH, THE fee is \$5 for each set of plats[, except that a].

15 (II) A fee is not required for plats [or microfilm aperture cards] 16 showing property or rights-of-way to be acquired or granted by the State Highway 17 Administration.

18 (III) THE CLERK MAY ASSESS ADDITIONAL FEES IF REQUIRED BY
 19 LOCAL LAW OR ORDINANCE.

20 (e) Each plat shall be signed and sealed by a professional land surveyor or 21 property line surveyor licensed in the State.

(a) (1) If the person offering a deed or other instrument affecting property for
record first pays the recording fees, the clerk of the circuit court of each county shall record
every deed and other instrument affecting property in [well-bound books to be named
"Land Records", if that is the practice in the county, or on microfilm, if that is the practice]
LAND RECORDS AVAILABLE TO THE PUBLIC.

28 (2) The clerk shall endorse on the deed or other instrument the time [he 29 receives] OF RECEIPT OF the document for recording and the endorsement shall show in 30 the [Land Records] LAND RECORDS.

(3) Any deed or other instrument affecting property which also affects
 personal property shall be recorded in the same manner in the [Land Records] LAND
 RECORDS only, and not in the ["Financing Records"] FINANCING STATEMENTS.

1 (b) If an interested party so requests, the ["Financing Records"] FINANCING 2 STATEMENTS provided for in § 9–402(9) of the Commercial Law Article shall include a 3 notation that the instrument is recorded among the ["Land Records"] LAND RECORDS. 4 The instrument also shall be indexed in the general alphabetical index provided in § 3–302 5 of this subtitle. The notation and indexing have the same effect as if the instrument were 6 recorded in full among the ["Financing Records"] FINANCING STATEMENTS.

7 (c) (1) The clerk may not refuse to accept any deed or other document entitled 8 to be recorded, solely on the grounds that the deed or document contains a 9 strike-through, interlineation, or other corrections.

10 (2) The clerk may refuse to accept for re-recording, a previously recorded 11 deed or document that has been corrected or altered by a strike-through, interlineation, or 12 similar corrective measures, and that has not been re-executed, [initialled] INITIALED, or 13 otherwise ratified in writing by the party or parties affected by the correction.

15 (a) (1) The clerk of the circuit court of each county shall make and maintain a 16 full and complete general alphabetical index of every deed, and other instrument [in a 17 well-bound book in his office].

18

(2) The index shall [be]:

19 (I) **BE** both in the name of each grantor, donor, mortgagor, and 20 assignor, and each grantee, donee, mortgagee, or assignee[. It shall include]; AND

21 (II) INCLUDE the book and page of the recordation of every 22 instrument designating these names.

(3) The clerk shall index every deed or other instrument [retaining a
vendor's lien both as a deed and as a vendor's lien,] in the same manner as mortgages are
indexed.

(b) [In every clerk's office where land records are not recorded in book form, the] THE clerk shall index every assignment of a mortgage, deed of trust, and release or partial [releases] RELEASE of a deed of trust, whether in long or short form[, in the general alphabetical index, and shall place an entry in the general alphabetical index where the instrument is indexed, on the same horizontal line, indicating the place of record of the original instrument being assigned or released].

32 [(c) The clerk of the circuit court of each county shall date each change or 33 correction made to information in the general alphabetical index on the horizontal line on 34 which the change or correction was made.]

1 [(d)] (C) (1) If a court [of equity] decrees a payment of cost or makes some 2 other decree for payment of money by a plaintiff, the clerk immediately shall [enter] INDEX 3 the plaintiff's name [in a separate index, known as the index of plaintiffs].

4 (2) Until the plaintiff's name is indexed, no lien under the decree 5 arises against the property of the plaintiff and no right of execution accrues on the decree.

6 [(e)] (D) (1) The clerk shall [include in the] index each property identifier 7 provided on an intake sheet under § 3–104(g) of this title [or, if the space available in the 8 index will not accommodate all of the identifiers, then as many as the space allows, giving 9 priority to identifiers in the order in which they are listed in § 3–104(g)(3)(i) of this title].

10 (2) The clerk shall rely on the instrument that is accompanied by the 11 intake sheet for indexing of grantor's and grantee's names.

13 The clerk shall [make a microfilm picture or other copy of every document he records 14 and] transmit [the microfilm pictures or copies] **RECORDED DOCUMENTS** to the State 15 Archivist [at the end of each year. When requested by the State Archivist, the clerk also 16 shall make a microfilm picture or copy of the general index].

17 3–304.

18 (a) Except as provided in subsection (e) of this section, the clerk shall [fasten 19 securely one copy of] **RECORD** each plat described under § 3–108 of this title [in a book 20 provided for that purpose or shall record the plat].

1 (a) [If] A FILING OFFICER SHALL RECORD a notice of federal lien, a refiling of  $\mathbf{2}$ a notice of federal lien, or a notice of revocation of any certificate described in subsection 3 (b) of this section [is] presented to the filing officer[, he shall cause the notice to be marked, 4 indexed, and recorded in an alphabetical federal lien index, showing on one line the name and residence of the person named in the notice, the U.S. government serial number of the  $\mathbf{5}$ 6 notice, the date and hour of filing, and the amount of the lien with the interest, penalties, 7 and costs. He shall file and keep all original notices so filed in numerical order in a file, or 8 files, and designated federal lien notices].

16 The fee for filing and indexing each notice of lien or certificate or notice affecting the 17 lien is \$3. [The office shall bill the district directors of internal revenue or other appropriate 18 federal officials on a monthly basis for fees for documents filed by them.]

20 (a) In this section, "holder of a subordinate interest" includes any condominium 21 council of unit owners or homeowners association that has filed a request for notice of sale 22 under subsection (c) of this section.
