### A BILL ENTITLED

#### 1 AN ACT concerning

#### Public Safety – Handgun Permit Requirement – Repeal (Maryland's Constitutional Carry Act of 2025)

- FOR the purpose of repealing the requirement that a person have a certain permit before
  the person carries, wears, or transports a handgun; repealing certain criminal
  prohibitions against a person who is at least a certain age wearing, carrying, or
  transporting a handgun; and generally relating to wearing, carrying, or transporting
  a handgun.

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 4 That Section(s) 5–301 through 5–314 and the subtitle "Subtitle 3. Handgun Permits" of

#### 2 (A) A PERSON MAY NOT WEAR, CARRY, OR TRANSPORT A HANDGUN WHILE 3 THE PERSON IS UNDER THE INFLUENCE OF ALCOHOL OR DRUGS.

#### 4 (B) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A MISDEMEANOR 5 AND ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 1 YEAR OR A 6 FINE NOT EXCEEDING \$1,000 OR BOTH.

9 (c) (1) A person may not shoot at any species of wildlife from an automobile or 10 other vehicle or, except as provided in § 4–203(b) of the Criminal Law Article [and Title 5, 11 Subtitle 3 of the Public Safety Article], possess in or on an automobile or other vehicle a 12 loaded handgun or shotgun, or a rifle containing any ammunition in the magazine or 13 chamber.

14 (2) If this subsection is violated by an occupant of a vehicle which has 2 or 15 more occupants and it cannot be determined which occupant is the violator, the owner of 16 the vehicle, if present, shall be presumed to be responsible for the violation. In the absence 17 of the owner of the vehicle, the operator of the vehicle shall be presumed to be responsible 18 for the violation.

19 (3) Provisions of this subsection do not apply to a disabled person who 20 obtains a special permit under § 10–307 of this title.

21 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 22 October 1, 2025.
