3 4 5 6	(a) This Act is contingent on the Department of Disabilities certifying that the Department has sufficient staff to administer the Maryland Disability Service Animal Program under Title 7, Subtitle 12 of the Human Services Article, as enacted by Section 1 of this Act.
7 8 9 10	(b) On or before October 1, 2026, the Department of Disabilities shall notify the Department of Legislative Services whether the Department has certified that the Department has sufficient staff to administer the Maryland Disability Service Animal Program.
11 12 13 14 15	(c) (1) If the Department of Legislative Services receives notification that the Department of Disabilities has sufficient staff to administer the Maryland Disability Service Animal Program on or before October 1, 2026, this Act shall take effect on the date the notice is received by the Department of Legislative Services in accordance with subsection (b) of this section.
16 17 18 19	(2) If the Department of Legislative Services receives notice that the Department of Disabilities lacks sufficient staff to administer the Maryland Disability Service Animal Program on or before October 1, 2026, this Act, with no further action required by the General Assembly, shall be null and void.
20 21	SECTION 3. AND BE IT FURTHER ENACTED, That, subject to Section 2 of this Act, this Act shall take effect October 1, 2025.
