- 5 FOR the purpose of establishing enhanced open meeting requirements for each local board 6 of elections and each local board of canvassers; and generally relating to open 7 meeting requirements for local boards of elections and boards of canvassers.

## 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 19 That the Laws of Maryland read as follows:

### Article – Election Law

22 (A) EACH LOCAL BOARD SHALL MAKE PUBLICLY AVAILABLE ON ITS 23 WEBSITE EACH OPEN MEETING AGENDA, TOGETHER WITH A SUMMARY OF ANY
