1 AN ACT concerning

2 **St. Mary's County – Alcoholic Beverages – Class A License Quota**

3 FOR the purpose of altering the quota for the number of Class A alcoholic beverages
4 licenses that may be issued in the 8th election district in St. Mary's County; and
5 generally relating to alcoholic beverages licenses in St. Mary's County.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Alcoholic Beverages and Cannabis**

19 28–102.

3 (a) The Board may not:

4 (1) issue more than one Class A license:

5 (I) for every 1,350 individuals **THAT LIVE** in an election district in
6 the county **OTHER THAN THE 8TH ELECTION DISTRICT; AND**

7 (II) **FOR EVERY 4,000 INDIVIDUALS THAT LIVE IN THE 8TH**
8 **ELECTION DISTRICT; or**

9 (2) approve the transfer of a license issued under item (1) of this subsection
10 from one election district to another election district unless the transfer can be made
11 without exceeding the license [quota] **QUOTAS** provided in item (1) of this subsection.

12 (b) The Board shall use the population statistics from the most recent County
13 Planning Commission annual report to maintain the license [quota] **QUOTAS** provided in
14 subsection (a)(1) of this section.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
16 1, 2025.
